P&A Plug 2: Pictured Cliffs, Fruitland, Kirtland and Ojo Alamo formation tops: Mix and pump balanced plug of 51 sx from 2270'. Pull up to 954'.

P&A Plug 3: Nacimiento formation top: Mix and pump balanced plug of 14 sx from 954' to 774'. Pull up to 325'.

P&A Plug4: Surface casing shoe to surface. Mix and pump plug of 30 sx from 325' to surface. TOOH.

7-13-2022:

Cut off WH, TOC in casing at 39', annulus at 38'. Install P&A marker. Top off cellar with 21 sx.

- Well Pad Legal Description, specifically Section, Township and Range
- Well Pad API Number
- Well Pad Plug Date
- Well Pad Operator Name


