9/4/2022: Test BOPS. Drill 12.25 intermediate hole to 5180 ft.

9/6/2022: Run 9.625 inch 40 lb J-55 intermediate casing to 5167 ft. Pump 20 bbls fresh water, followed by 845 sks of 11.3 ppg lead cmt, 320 sks of 14.8 ppg tail cmt. Drop plug and displace with 390 bbls fresh water. 100 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 1600 for 30 minutes, good test.

9/6/2022: Drill 8.75 inch production hole to 10949 ft then switch to 6.75 in hole to 16448 ft.

9/12/2022: Run 5.5 inch 20 lb P-110 production casing to 16431 ft MD. Pump 40 bbls fresh water, then 435 sks of 10.5 lead cmt, 1200 sks of 13.2 ppg tail cmt. Drop plug and displace with 20 bbls retarder and 344 bbls fresh water. 0 bbls returned to surface. Est TOC at 517 ft.
