WELLBORE DIAGRAM

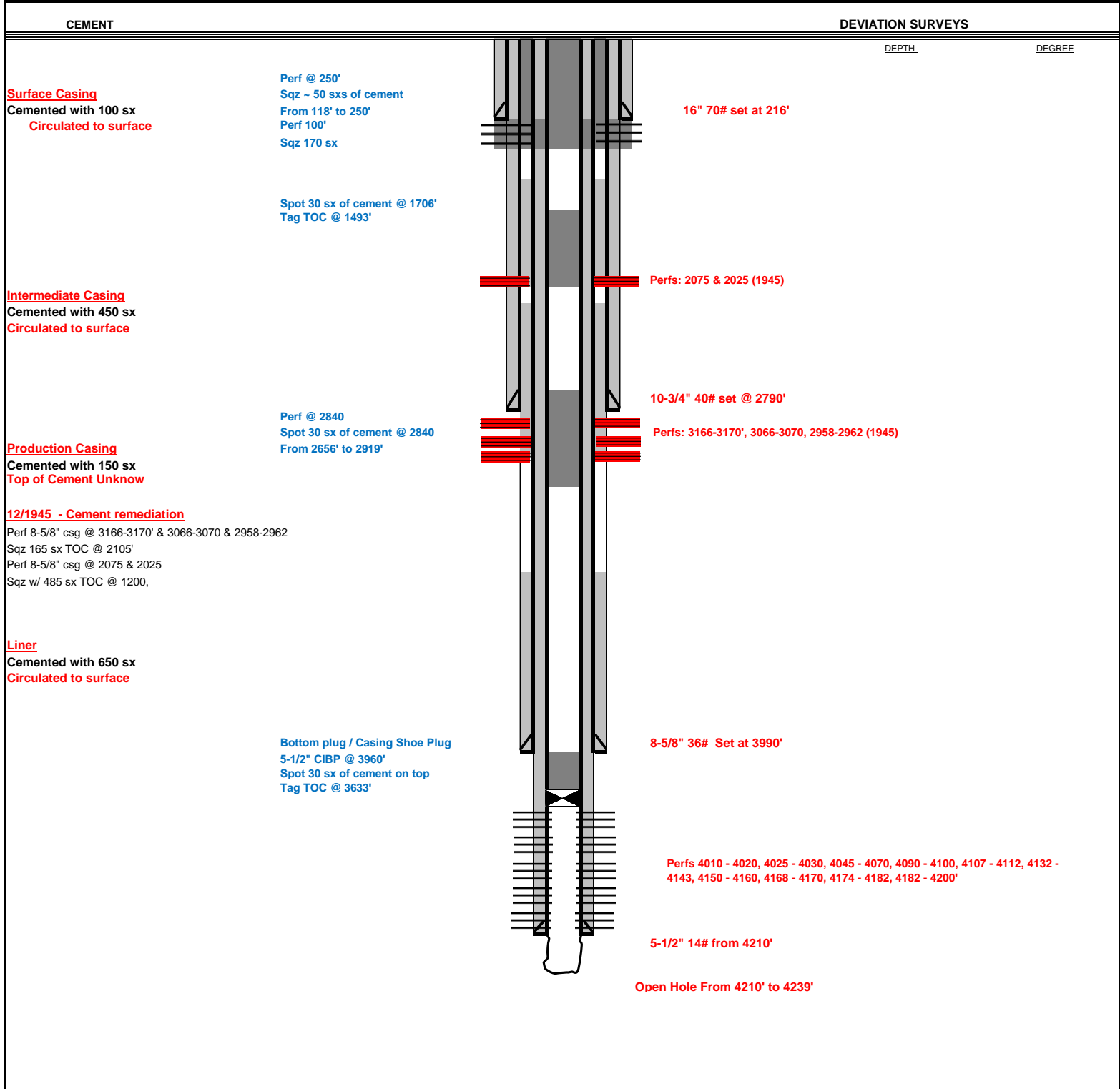
