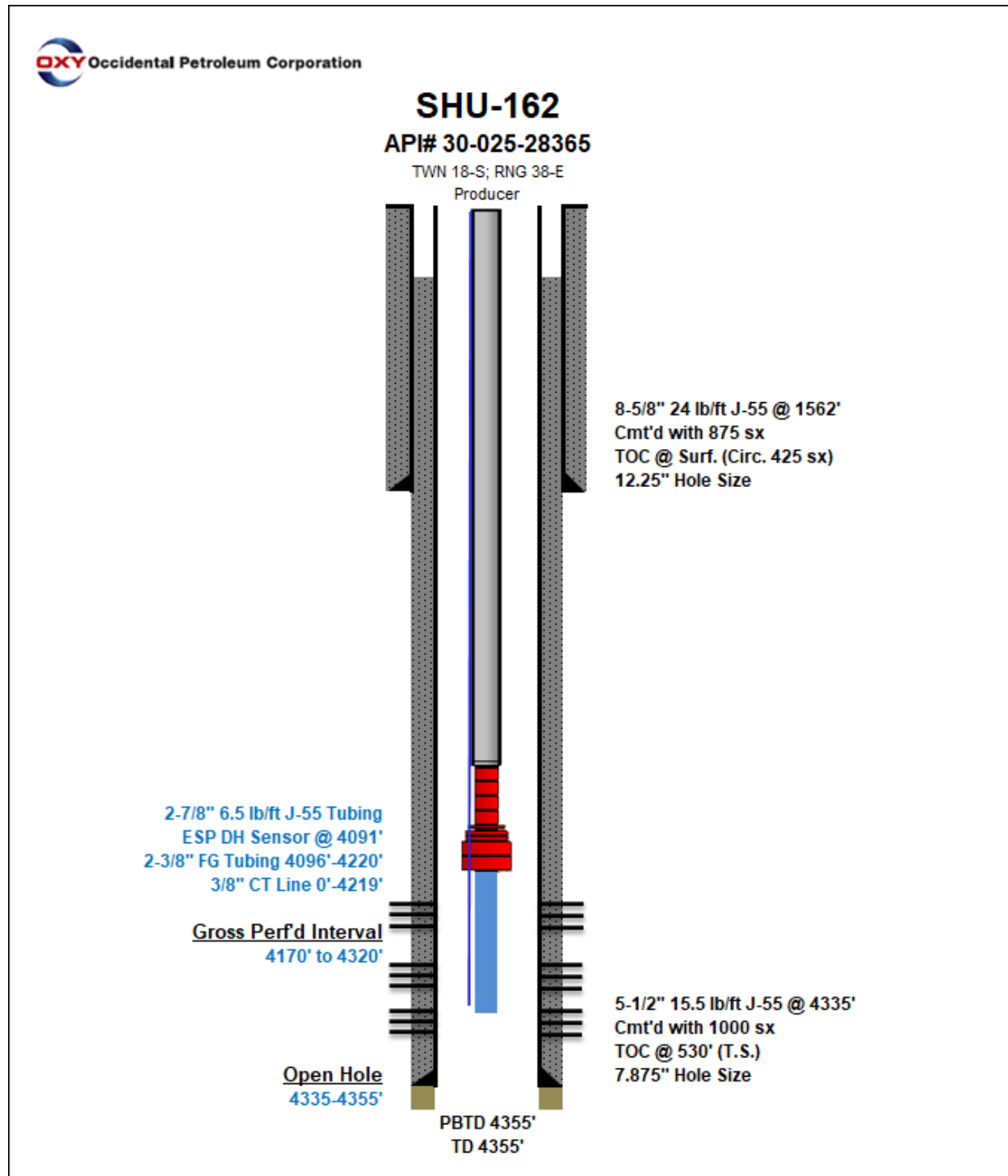

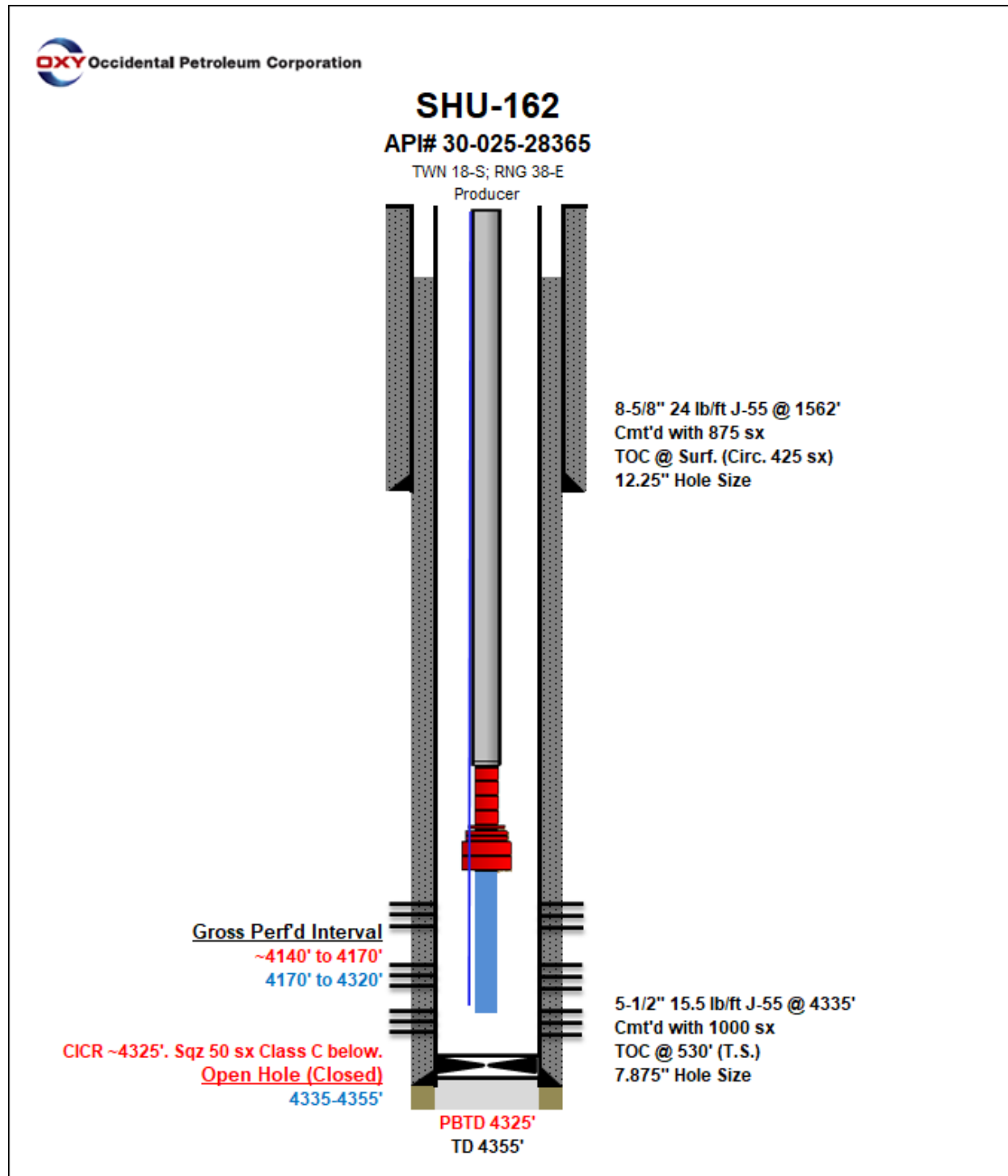

6. AT perfs w/ ~6000 gal 15% HCl.
7. Perform scale squeeze.
8. RIH w/ ESP, fiberglass tailpipe and capstring.
9. Return well to production.
