Actual Procedure: 3/7/2022: Test BOPS. Drill 12.25 intermediate hole to 3649 ft. 3/8/2022: Run 9.625 inch 40 lb J-55 intermediate casing to 3633 ft. Pump 40 bbls gel spacer, followed by 800 sks of 12.8 ppg lead cmt, 300 sks of 14.8 ppg tail cmt. Drop plug and displace with 272 bbls of fresh water. 120 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 1500 for 30 minutes, good test. 3/8/2022: Drill 8.75 inch production hole to 8700 ft then switch to 7.875 inch to 13576 ft. 3/15/2022: Run 5.5 inch 20 lb P-110 production casing to 13560 ft MD. Pump 50 spacer, then 480 sks of 10.5 ppg lead and 750 sks of 13.2 ppg tail cmt. Drop plug and displace with 20 bbls sugar water, 280 bbls brine. 0 bbls returned to surface. Est TOC at 643 ft.
