Spud & set surface casing: The County Fair Fed Com 602H was spud utilizing surface rig, Transcend #4 on 10/2/2021. Drilled 17-1/2" hole to 1336' KB. RAN 13.375" CASING AS FOLLOWS. FLOAT SHOE 1.50', 1 JT OF CASING 41.46', FLOAT COLLAR 1.75', FOLLOWED BY 32 JTS 13.375" 54.5# BTC J-55 CASING, BTC TO 1,295' (KB) 1,336' (GL). CENTRALIZED JT 1,3 & EVERY 3RD JT TO SURFACE. Tested Casing @ 1,500 PSI for 30 minutes via H&P #537 on 12/1/2021. CEMENTED 13-3/8" CASING AS FOLLOWS. PRE FLUSH LINES W/FW, TEST LINES TO 2,500 PSI, MIX & PUMP 30 BBLS FW SPACER W/ BLUE DYE FOLLOWED BY 249 BBLS LEAD @ 13.5 PPG (800 SKS). 2ND BULK TRUCK HAD ABNORMAL DEBRIS PREVENTING PROPER DUST FLOW FOR CONSTANT DENSITY MIXING. SEVERAL ATTEMPTS WERE MADE TO CORRECT THE ISSUE. TAIL CEMENT WAS STARTED BUT CANCELLED AND DECISION WAS MADE TO DISPLACE CEMENT FROM WELLBORE AND HAUL ALL WASTED CEMENT TO DISPOSAL. UNIVERSAL WAS CONTACTED TO START INVESTIGATION AND ALSO GET NEW JOB ON THE ROAD. ALL VOLUMES WERE CALCULATED AND DISPLACEMENT OF CEMENT WAS ACCURATE TO SURFACE. WELLBORE WAS DISPLACED CLEAN. Cement used: Class C, HSR. Rigged down 10/4/21 @ 12:00. Operations were suspended between the completion of the surface section and move-in of the rig capable of reaching TD.
