Plug 3 (102' – Surface) Mix and pump: 35 sxs Class G Neat, 15.8 PPG, 1.15 Yield to surface. LD tbg. ND BOP. WOC. Cut off WH. Install dry hole marker. Fill csg & cellar w/ 15 sx cmt. RDMO.

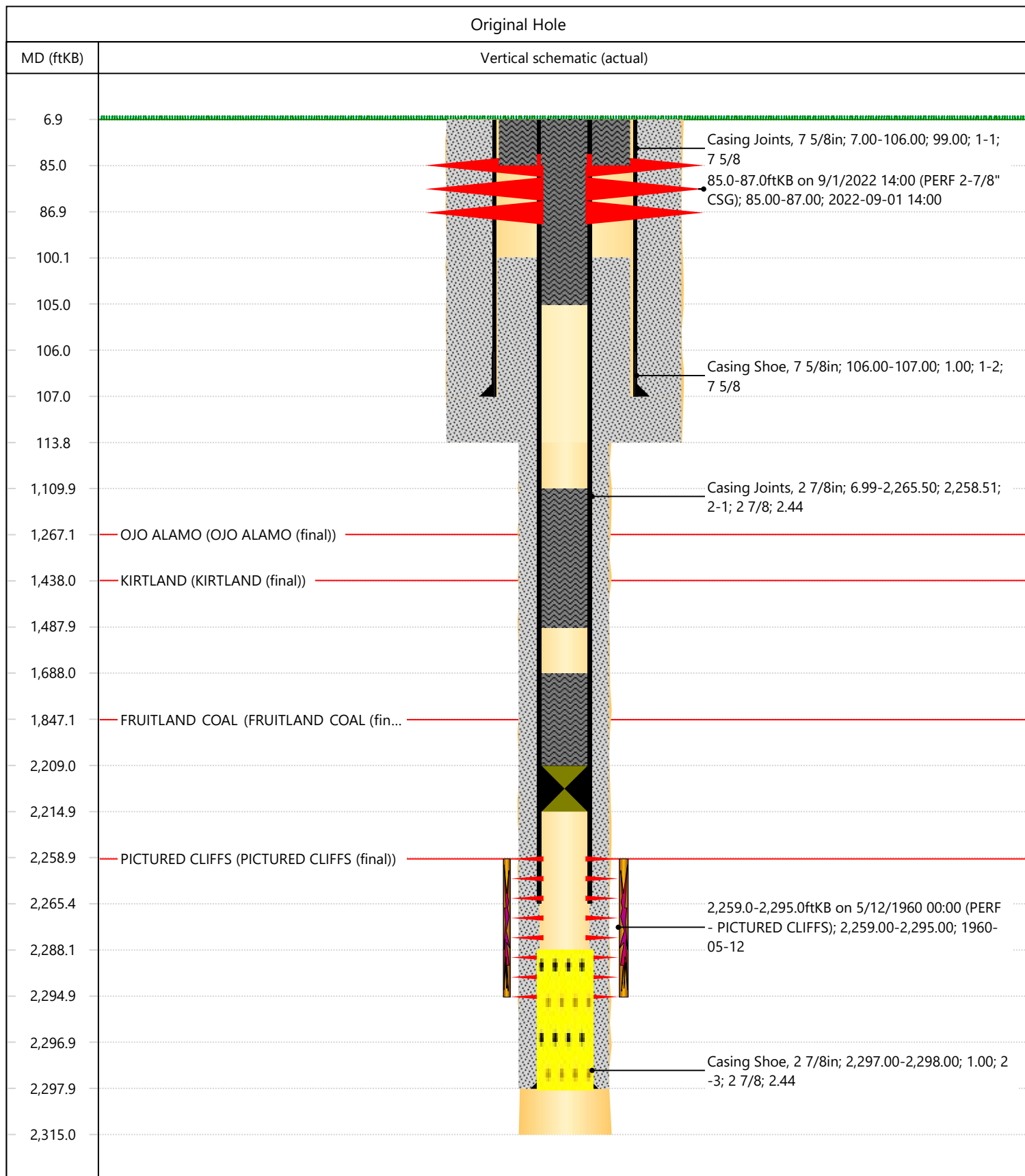
