1. TOOH with Production Equipment. Rods/Tubing/Pump from ~ 5,400'
2. PU and RIH with 7 AW scraper on 2-7/8" L-80 WS to 5114'
3. PU 7" CIBP and set @ ~5064"
4. Spot 35 cement cap through bailer or 25 sx through tubing on top of CIBP.
5. Tag cement top. Record depth.
6. Circulate well and load casing with packer fluid. Pre-test casing.
7. Notify NMOCD for MIT.




