OXY USA INC requests approval to add HEADS CC 9_4 FEDERAL COM #311H to PLC 750-E. This well will be included in a currently approved pools of PURPLE SAGE WOLFCAMP (GAS) and currently approved proposed consolidated leases (CA WC 9-4 T24S R29E) in PLC 750-E.

The facilities described in PLC 750-E are unchanged – each facility has a sales-quality orifice meter (BLM gas FMP or equivalent meter) that continuously measures gas volume before it leaves the facility. Production upstream of the facility gas FMP or equivalent meter is allocated to each well based on well test.

This request is for gas production only. Oil production will be handled through an amendment to OLM-259 for Whomping Willow CTB Train #3 (F-15-T24S-R29E).
