1. Perform Bradenhead test per NMOCD regulations.
2. Rig up kill truck with calibrated chart.
3. Load casing to +/- 550 psig and chart well for minimum of 30 minutes to MIT casing.
 - a. Contact NMOCD to have test witnessed before charting.
4. Relieve pressure from charting and isolate all casing valves.
5. RD kill truck and move out.




