Set 5 1/2 CIBP @ 1766'. Circ hole w/ MLF. Pressure tested csg, Held 500 PSI. Spotted 25 sx class C cmt @ 1766-1519'. ND BOP. Spotted 80 sx class C cmt @ 440' & circulated to surface. 
