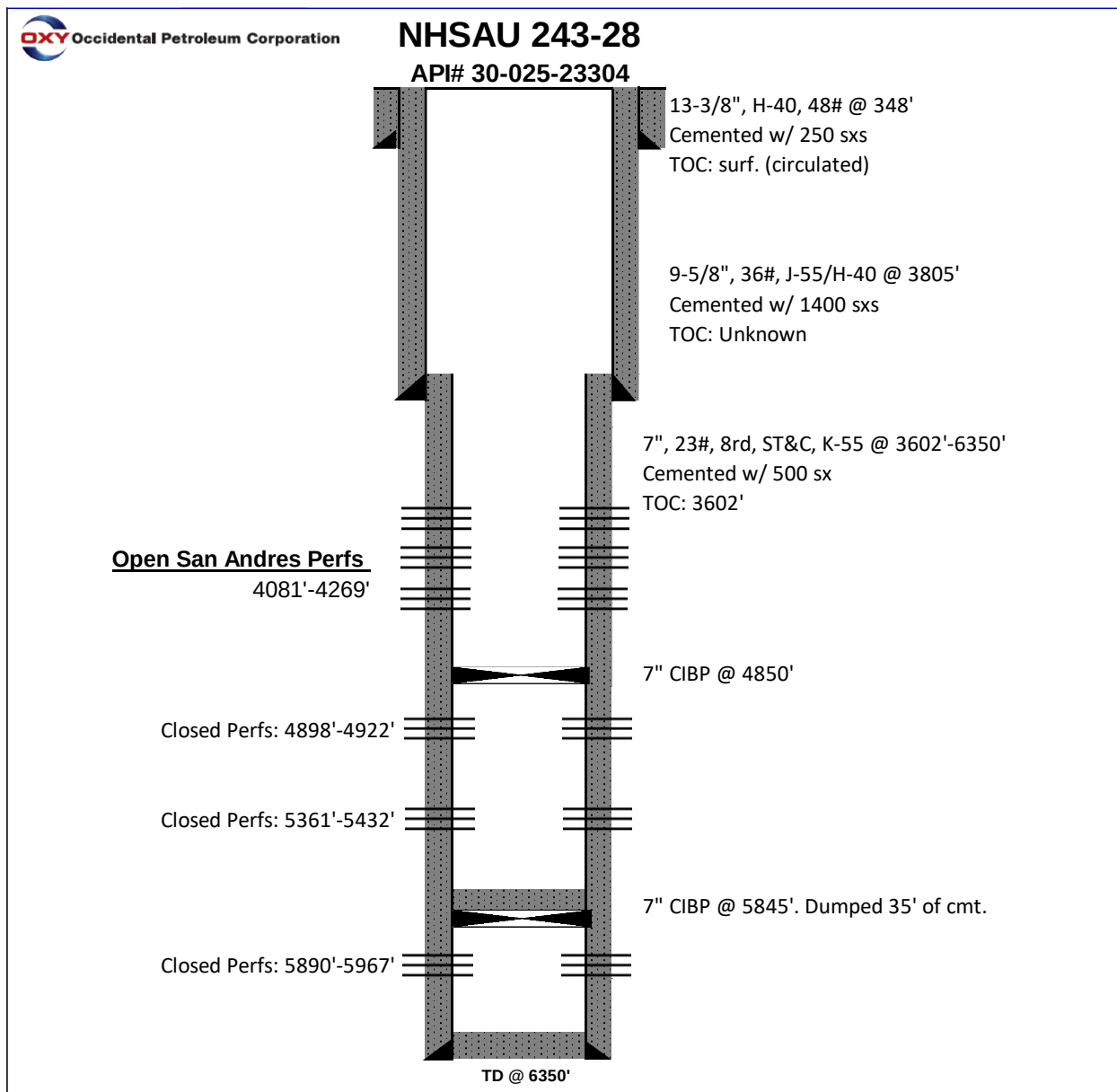

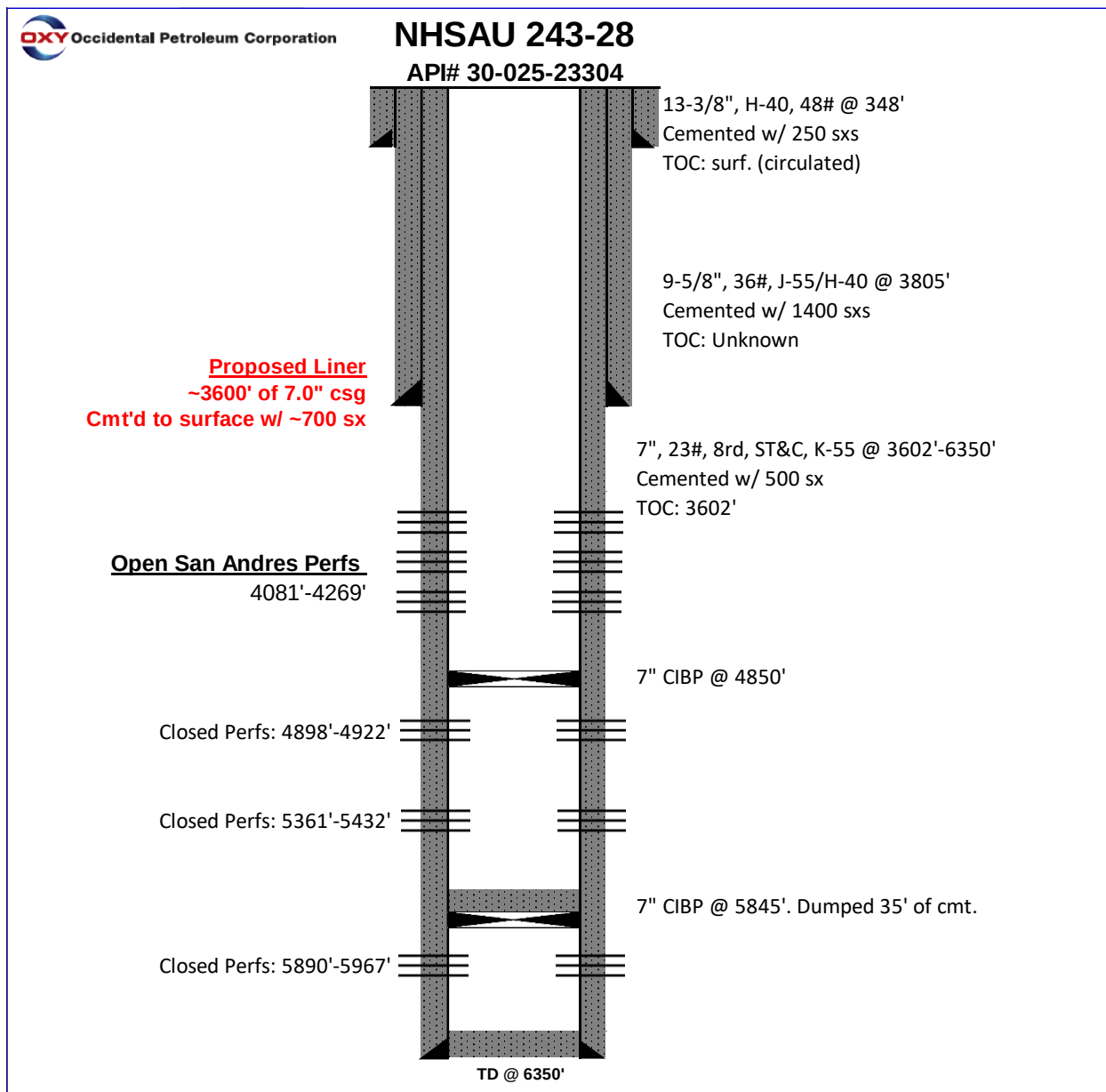

- 2) POOH w/ ESP eqpt
- 3) RU WL x Set CIBP @ 3800' x RD WL
- 4) Set RBP @ 1000'
- 5) Dig out & replace wellhead
- 6) Fish RBP
- 7) PU liner equipment as follows:
 - PU 7.0" liner shoe, 1 jt 7.0" liner, 7.0" float collar, ~3560' of 7.0" liner
- 8) Land liner shoe at ~3602'
- 9) Cement liner in place to surface
- 10) Set csg slips & packoff, cut liner excess, & Flange on new 7.0" csg spool
- 11) PU 6-1/8" bit x RIH x CO to top of float collar
- 12) Drill out float equipment & CIBP at ~3800'. CO to below perfs ~4450'.
- 13) POOH w/ bit
- 14) RIH w/ ESP eqpt
- 15) Return well to production
