8/12/2022 - Start frac stages 1-42 with 2 shots per foot for a total of 1008 shots, 0.41" in size using 24,231,351 lbs of proppant and 634,823 bbls of brackish water. Total interval from 12,463' to 22,897'.

8/27/2022 - Finish last stage frac. Rig down.

9/2/2022 - Ready to produce.

9/5/2022 - Open well, start flowback operations. Turn to production.
