 - 3751 – 3812
 - 3829 – 3865
 - 3875 – 3885
8. RIH w/ sonic hammer
9. Acidize well with 5,000 gallons of 15% HCL
10. POOH laying down workstring
11. Hydrotest tbg to 80% burst
12. RIH w/ TAC, tbg and rods
13. Long stroke pump and ensure good pump action
14. RTP

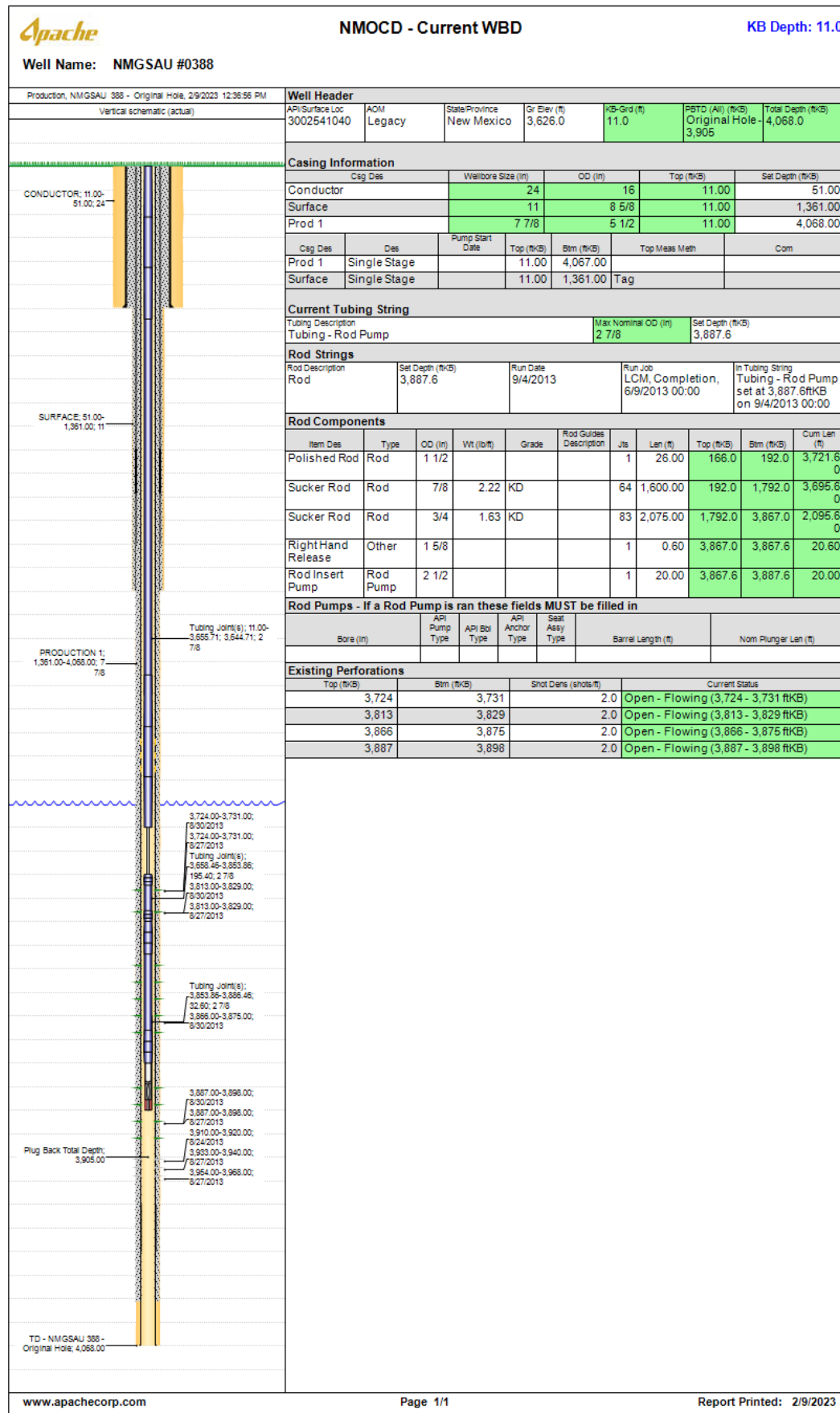
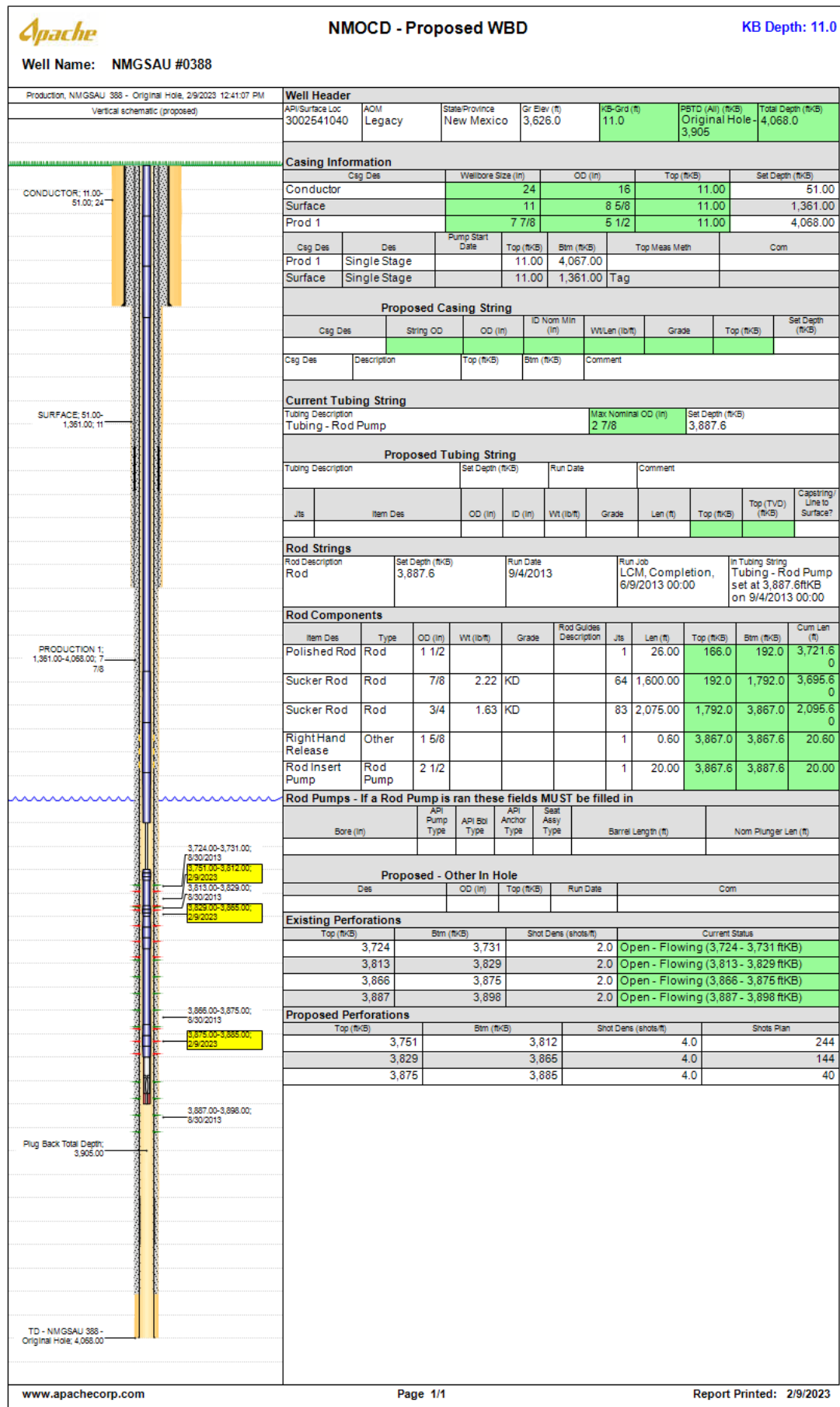
Figure 1 – Current Wellbore Diagram
