Directions: From the Junction of HWY 8 and HWY 42 (Monument, NM), head east on HWY 42 for 2 Miles. Turn South into lease road. Head south on lease road for .8 miles, turn left and go east for .7 miles. Turn Right and head south for .25 miles. Turn left and head west for .1 mile. Drive into location.

1. Check Anchor 1 Week prior to Rig up
2. Check surface pressures and blow down well if needed. Kill well with 10# brine if needed.
3. MIRU Pulling Unit
4. Pull Rods and TBG. Be prepared to fish Rods, will need Xylene to clean up
5. RIH w/ 4-1/2" Bit and scrapper to 6800'
6. POOH w/ bit and scrapper
7. RU Wireline
8. Set CIBP @ 6800' and cap w/ 25' CMT on top.
9. RD Wireline
10. Load hole w/ fresh water and test to 500# for 15 minutes.
11. Run 100' of kill string in the well and SI well
12. RDMO Pulling Unit
 - a. Send rods and TBG to inventory (MCD)

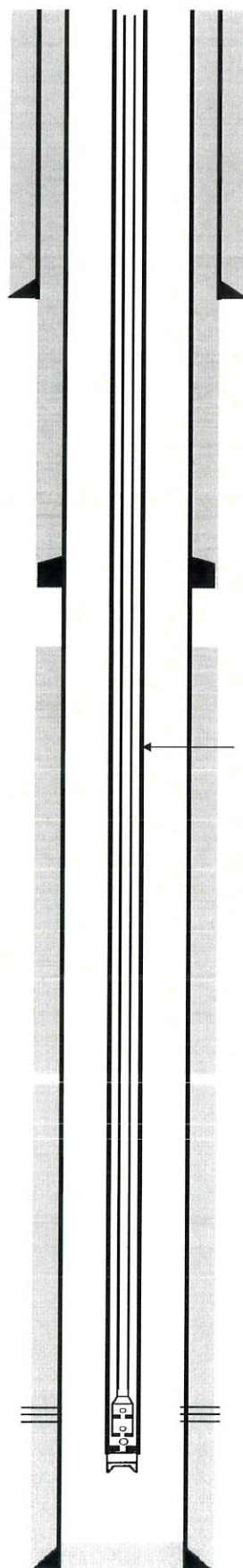
