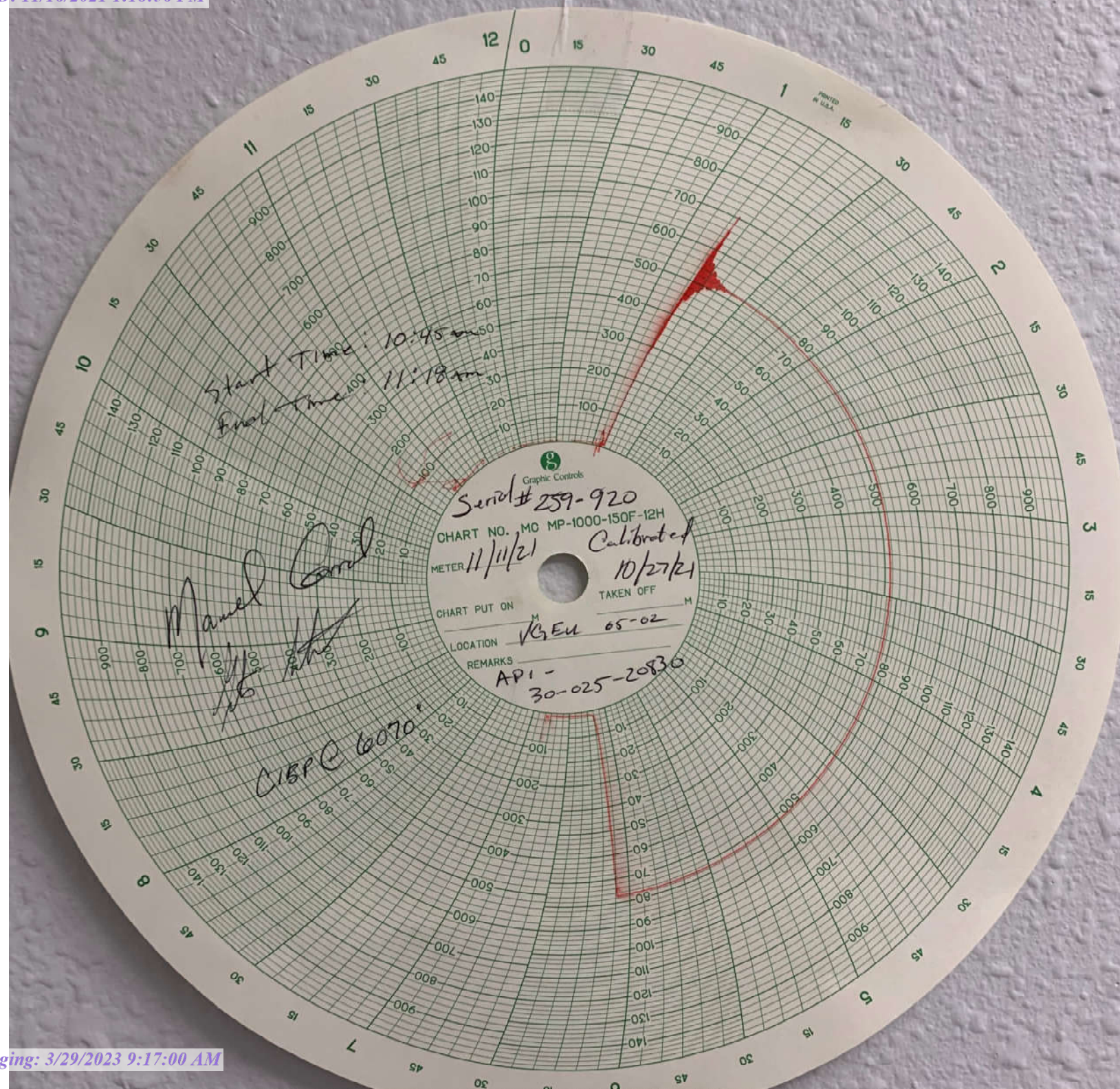

ConocoPhillips Company respectfully requests to temporarily abandon this well following casing repair. We proposed to cancel the previously proposed permanent abandonment to evaluate options for using this well. The procedure is below and schematics are attached.

- MIRU WSU. ND WH, NU BOP.
- TOOH w/ tubing and ESP.
- PU bit and scraper. RIH to ~6,075'
- PU bridge plug and packer. Set bridge plug @ 6,070'. Hunt for leak.
- Isolate leak and establish injection rate.
- Set 2nd RBP @ TBD location.
- Repair casing leak by cement squeeze if deeper than 20' or surface cut and replace if shallower than 20'.
- Load casing and pressure test to 550 psi.
- Contact NMOCD to witness MIT and bradenhead test.
- Run MIT at 550 psi for 30 minutes.
- Turn well over to operations. RDMO.

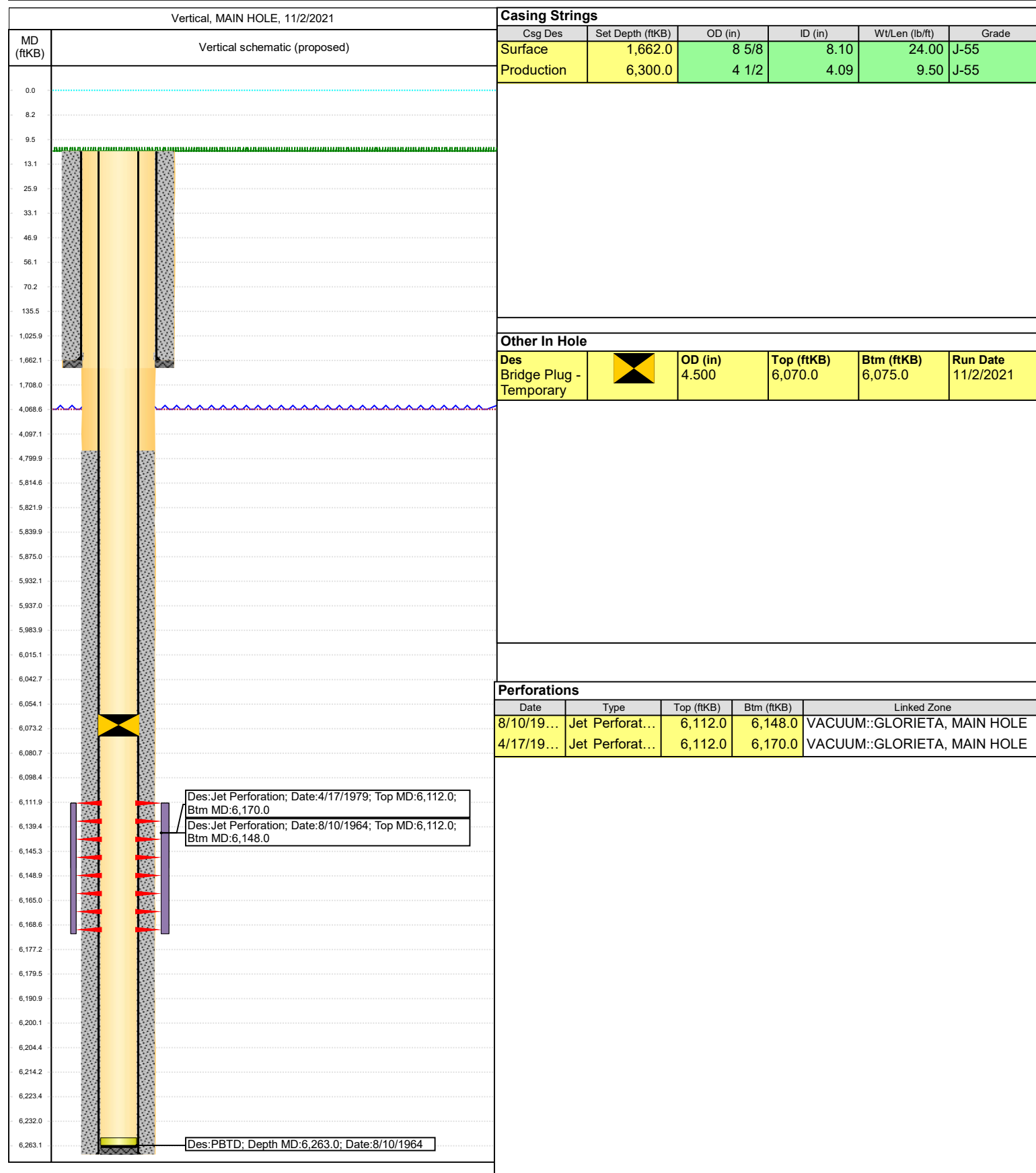

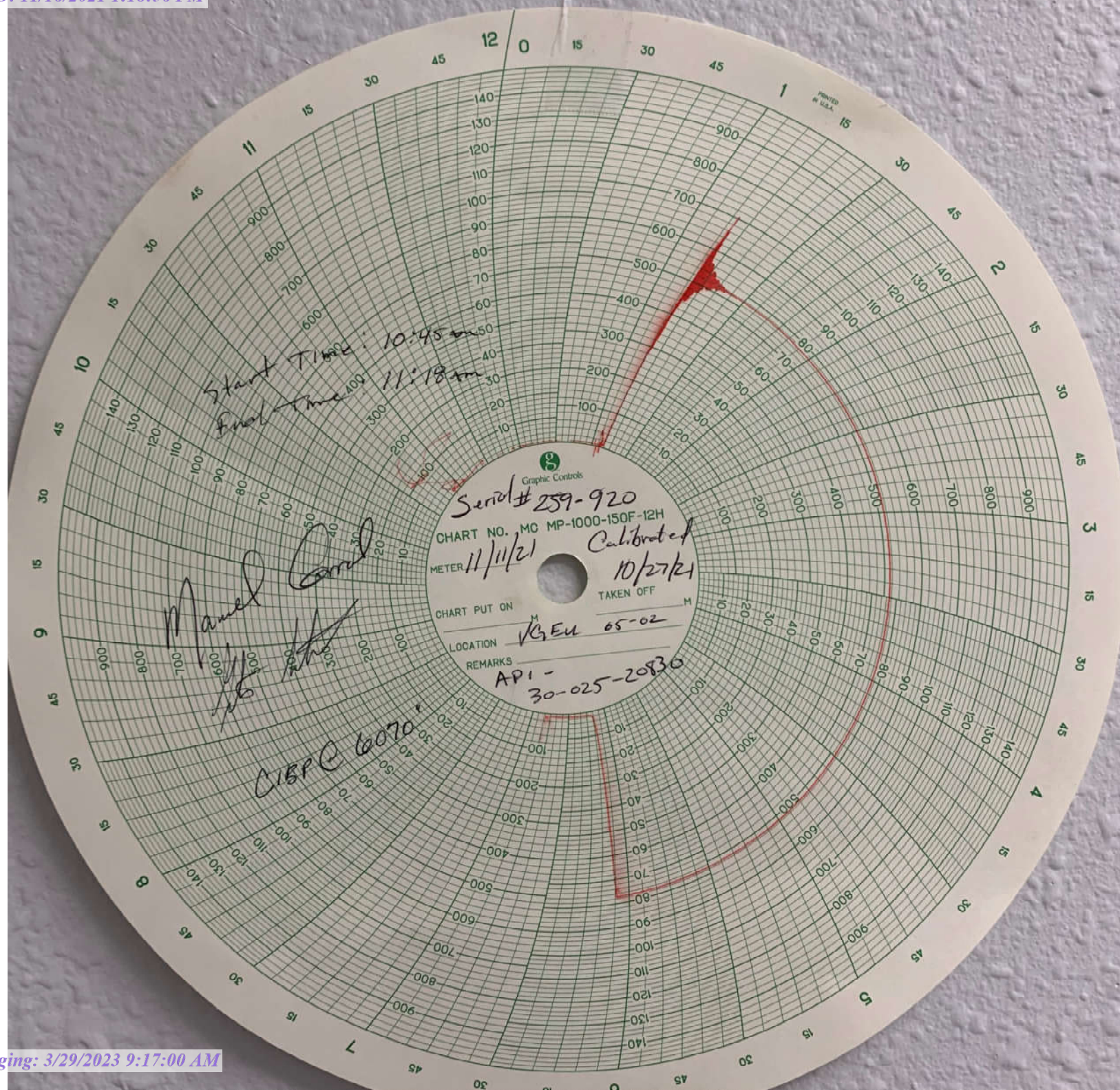
