

- 1. Perform Bradenhead test per NMOCD regulations.
- 2. Rig up test truck with calibrated chart.
- 3. Load casing to approximately 550 psig and chart well for minimum of 30 minutes to MIT casing.
 - a. Contact NMOCD to have test witnessed before charting.
- 4. Relieve pressure from charting and isolate all casing valves.
- 5. RD test truck and move out.
