MIRU rig and equipment.

3-16-2021:

SITP = 15, SICP = 75, BH = 0. TOO H with rods and pump. NDWH, NU BOP. TIH with bit and string mill to 1300'. TOO H. TIH with cement retainer, set retainer at 1290'. Load and roll hole, PT casing, did not test.

P&A Plug 1: Fruitland perforations: Mix and pump plug of 30 sx below retainer.

P&A Plug 2: Fruitland, Kirtland, Ojo Alamo to surface: Sting out of retainer and place 100 sx above retainer.

Begin to pull tubing, pulled and LD 15 joints, then tubing became stuck. Were not able to free tubing to LD remaining tubing. SDFN.

3-17-2021:

RIH with WL, found TOC inside tubing at 272'. POOH. RIH, ran free point, tubing free at 265'. RIH, cut tubing at 245'. POOH.

TIH with tubing to top of fish, load and roll hole. PT casing, good test.

P&A Plug 3: From top of fish at 245' to surface. Mix and pump plug of 24 sx with circulation to surface. TOO H.

ND BOP, cut off WH. TOC in annulus at 16', in casing at 22'. Install P& A marker. Top off casings and cellar with 25 sx.

Release Rig.

All cement used was Class G mixed at 15.8 ppg, yield 1.15 cuft/sx



3/17/2021: Ran free point. Tubing stuck at 265'. Cut off at 245'. Plug 3: 265' to surface: Mixed and pumped 24 sx, and circulated cement to surface.

3/16/2021: Set CR at 1290' per BLM request. PT casing, did not test. Plug 1: Fruitland perms: Squeezed 30 sx Class G cement through CR. Plug 2: Inside casing: Spotted 100 sx on top. Began TOOH and tubing became stuck. Could not free. Tried to reverse circulate, but casing failed at surface.
