 11/5/22: Held JSA. DXP on loc. BD 20# on casing and 100ppm H2S. LD remaining tbg; total 4500'. Prep road for pipe trailer.

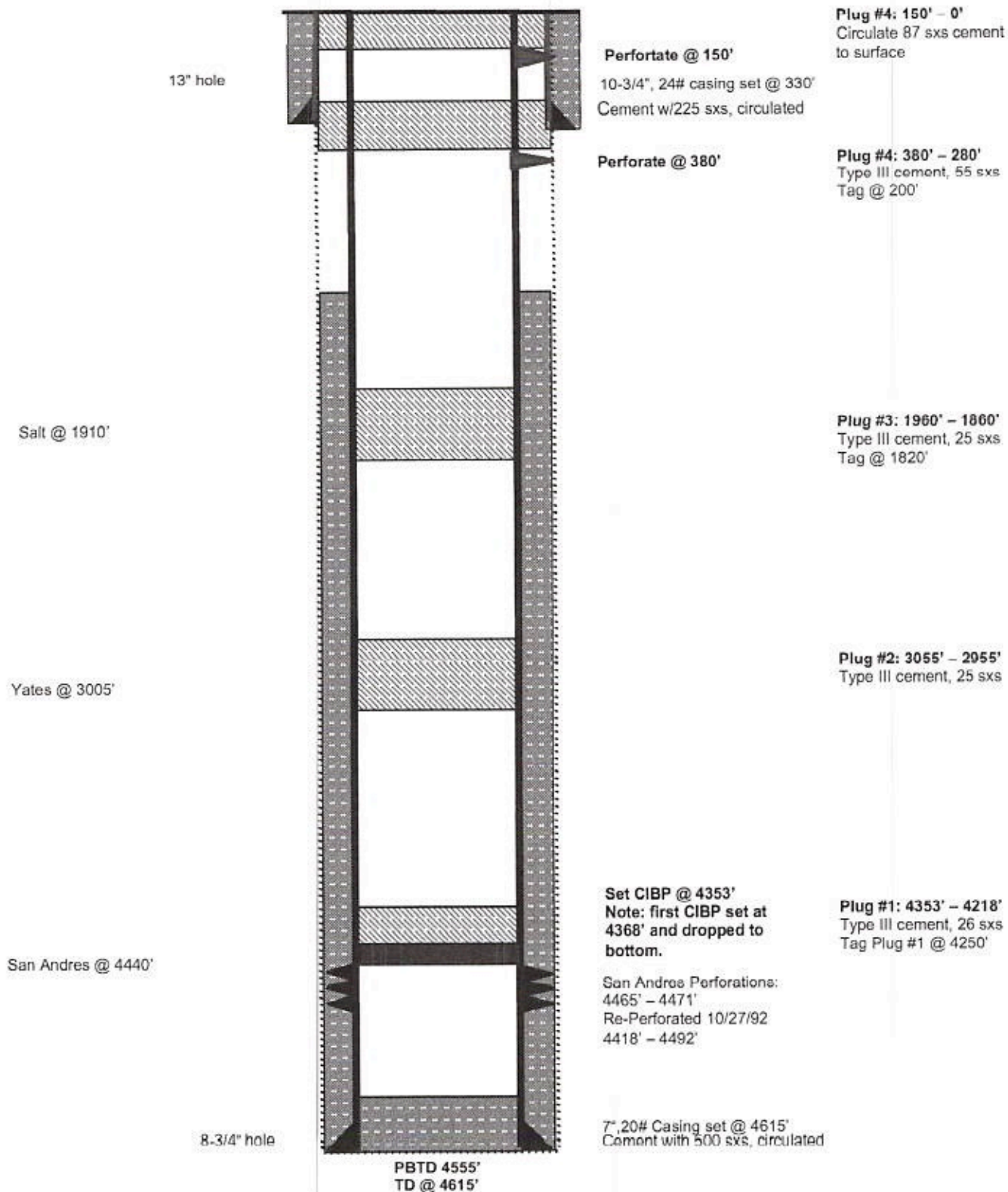
