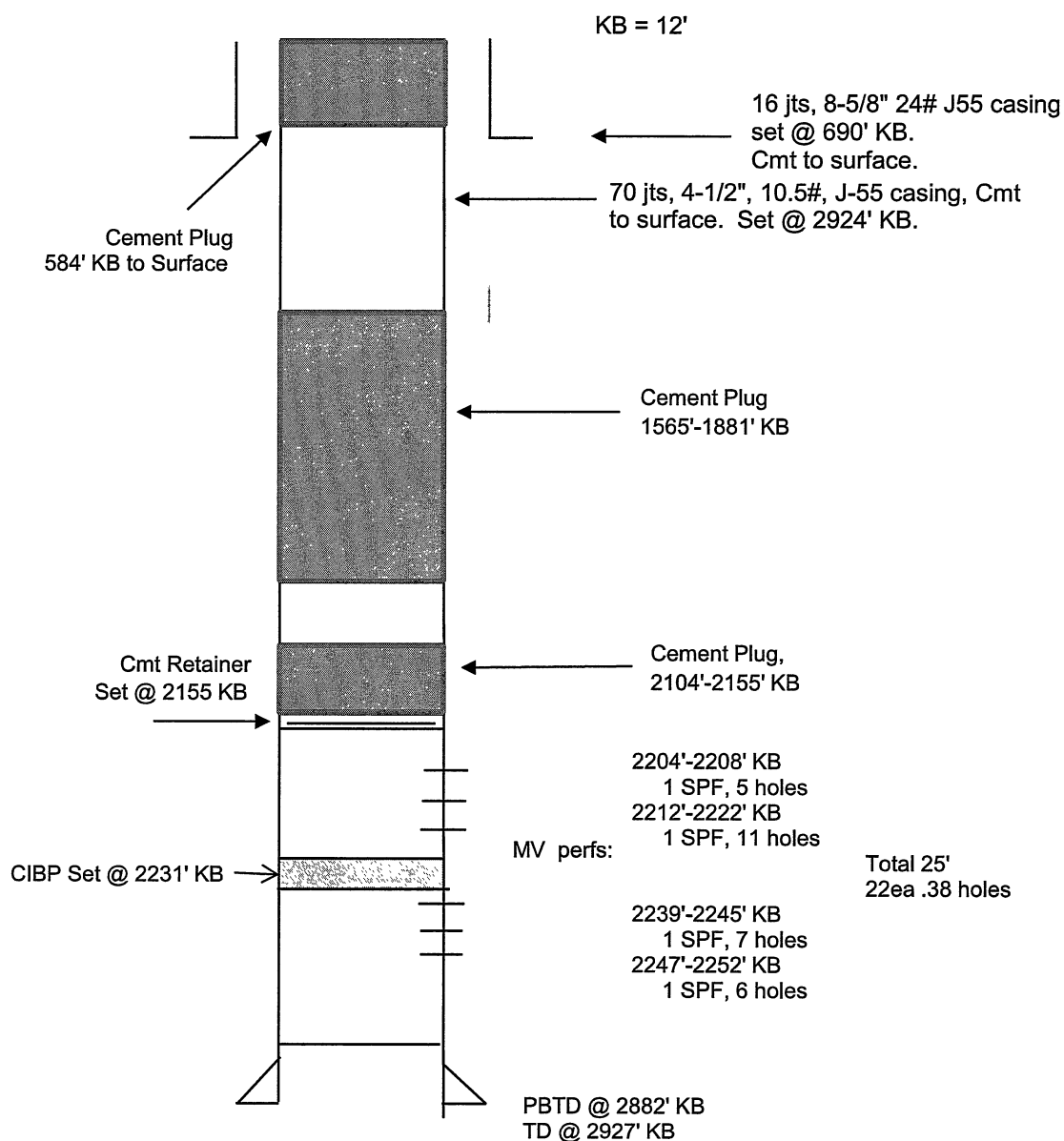

Test good. Batch 6 sx Type III 14.6 Cmt, 1.5 Bbbs water, pumped and displaced with 8 Bbbs wate. 96' Plug. TOOH w/ 8 jts. tbg. Batch 20 sx Type III 14.4# Cmt and displaced with 5.5 Bbbs water. 316' Plug. TOOH with 10 Jts. Tbg. Batch 150 sx Type III, 14.6#, 36 Bbbs water and cement to surface. Secure Location and RDMOSU and Cement equipment.

Throughout the entire job, communication, texts, and photos, were sent to Mark Decker, BLM AO. After Cmt hardend, P&A Marker installed, Location stripped and cleaned of equipment, risers, culverts, PJ, electrical equipment and poles. Location was re-contoured per onsite instructions the soil was ripped and seeded. Location had ditch reinstalled at entrance to location. Throughout the entire job, communication, texts, and photos, were sent to Mark Decker, BLM AO. Plugs Set at: 2155' KB - 2104' KB, 1881' KB - 1565" KB, & 584' KB to surface.
