

Description of Work Performed:

1. Started moving equipment to location (4/21/2023).
2. Finished moving equipment to location (4/22/2023).
3. Rigged up rig (4/23/2023).
4. Pressure tested 5-1/2" csg to 500 psi for 30 mins, good test. Tagged PBTD @ 956'. Ran CBL from 956' to surface. CBL shows no cmt behind 5-1/2" csg. Circulated well w/ mud. Spot 15 sxs Class C cmt @ 950' (4/24/2023).
5. Tagged TOC @ 806'. Perf @ 800', able to inject, but not getting returns. Squeezed 25 sxs Class C cmt. WOC. Tag TOC @ 653'. Perf @ 653', able to inject, but not getting returns. Squeezed 25 sxs Class C cmt (4/25/2023).
6. Tag TOC @ 585'. Perf @ 580', able to inject, but not getting returns. Squeezed 25 sxs Class C cmt. WOC. Tag TOC @ 492'. Perf @ 490', able to inject, but not getting returns. Squeezed 25 sxs Class C cmt (4/26/2023).
7. Tag TOC @ 428'. Perf @ 428', able to inject, but not getting returns. Squeezed 25 sxs Class C cmt. WOC. Tag TOC @ 424'. Perf @ 424', able to inject, but not getting returns. Squeezed 75 sxs Class C cmt (4/27/2023).
8. Tag TOC @ 310'. Perf @ 200', able to inject into 7" x 8-5/8" annulus, but not able to circulate. Able to circulate up 5-1/2" x 7" annulus. Squeezed 35 sxs Class C cmt out into 7" x 8-5/8" annulus. WOC. Circulate 66 sxs Class C cmt, filled up csg and both annuli (4/28/2023).
9. Performed 30 min bubble test. Cut off wellhead 3' below ground level. Verified cmt to surface in csg and both annuli. Installed 4' dry hole marker. Covered cellar. Dug up & cut off rig anchors. RDMO rig (4/29/2023).
