Actual Procedure: 11-6-2019 : Spud at 1700 with Aztec rig 777. Drill 12.25" hole to 888'. 11-7-2019: Set 9.625" 36 J-55 LT&C surface casing in 12.25" hole at 884'. Cemented lead with 210 sx 10% poz + 90% Class C + 5#/sk gel + 1/4 #/sk cello-flake + 0.2% D-SA1 + 0.4 D-MPA-1 + 0.4% D-CD-2 mixed at 13.5 #/gal with a yield of 1.70 cu ft/sk. Tail with 250 sx premium Class C + 1/4 #/sk cello-flake + 1% CaCl2 + 0.2% D-MPA-1 mixed at 14.8 #/gal with a yield of 1.34 cu ft/sk. Circulated to surface. Final pump in pressure was 490 psi. Bumped plug with 993 psi. Floats held cmt in place at 1645 on 11-7-19. 11-8-2019: Drill ahead 8.75" hole 11-12-2019: Drilled to TD 8250'. Drill string became stuck in Kirtland Fm while TOO. Many fishing efforts (reaming, jarring, washing) over next 5 days. 11-14-2019: Perforated drill collar at 2985' - 2988' with 12 shots. 11:16-2019: TOO and leave 241.55' fish (three 6.25" drill collars, three 8-625" stabilizers, one 6.5" survey tool, one 6.6" mud motor, & one 8-75" bit). Top of fish @ 2980'. Receive permission from BLM and NMOCD to plug well. 11-17-2019: Set plug 1 (??sx) from 2980' to 829'. Set CIBP at 800'. Set plug 2 (35 sx) from CIBP to 700'. Set plug 3 (??sx) from 120' to GL. Rig released at 1700. Well bore diagram & deviation survey attached.




