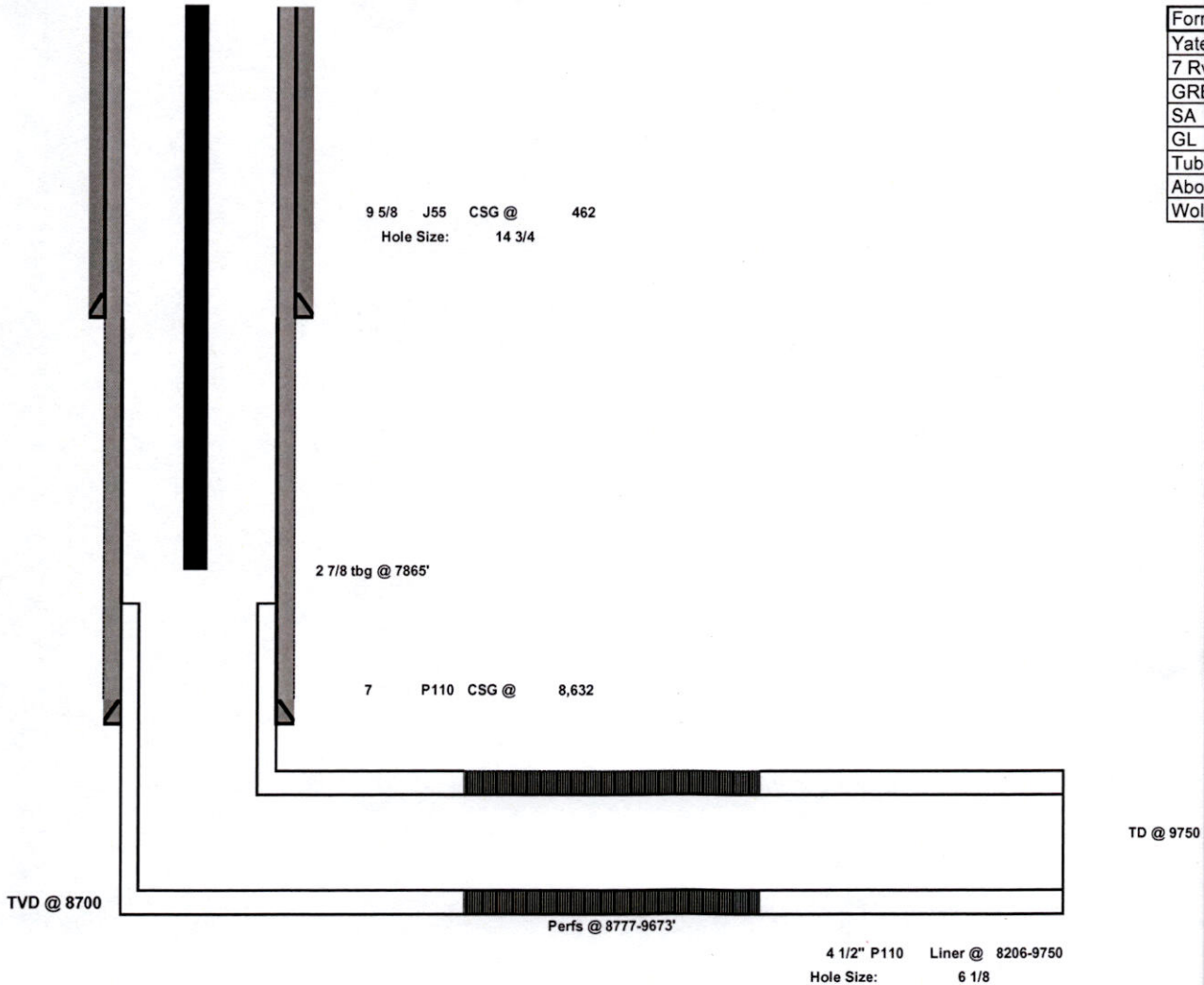

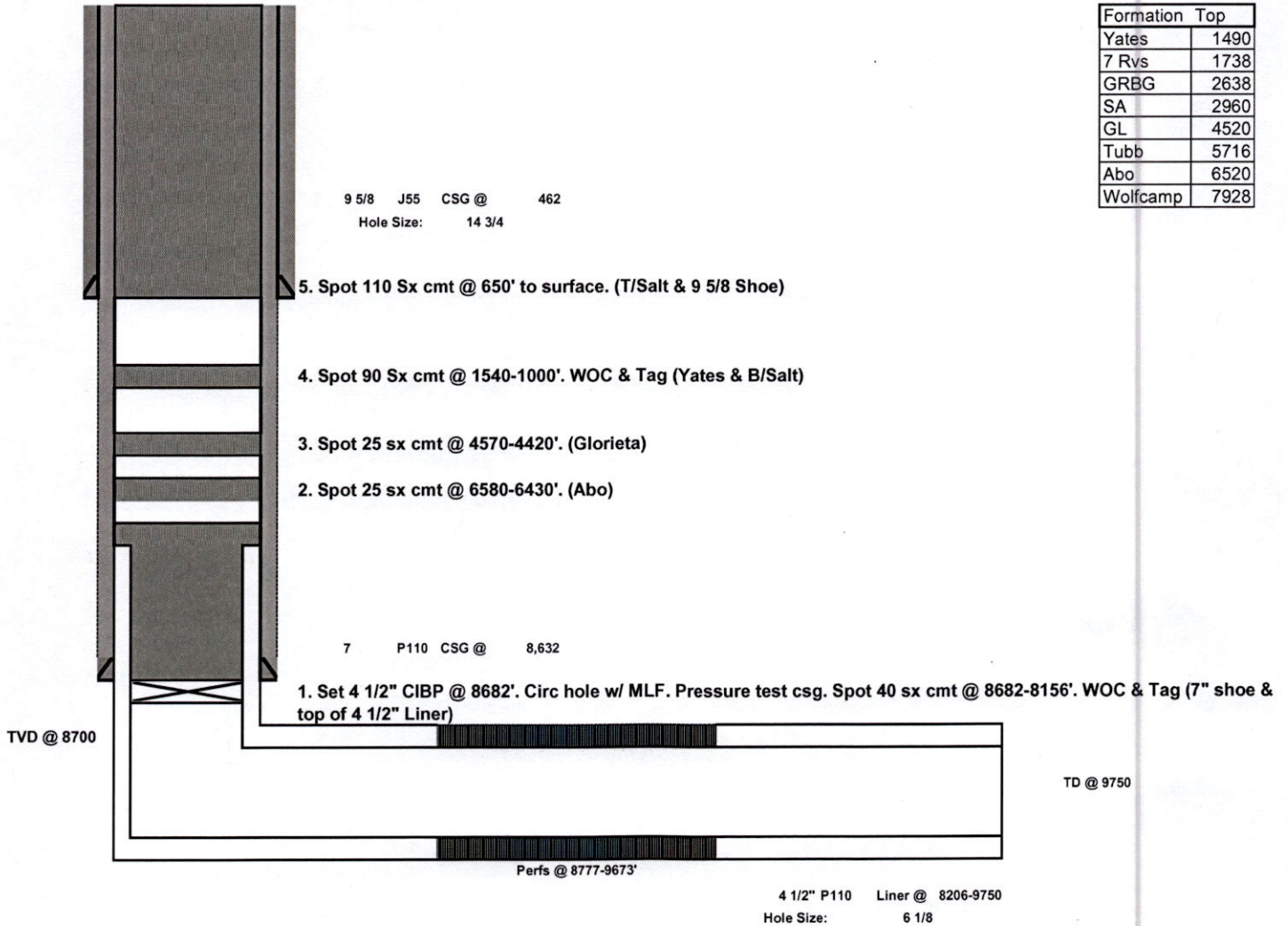

Conditions of Approval**

1. Operator shall place CIBP at 8,682' and place 40 sx of Class H cement on top as proposed. WOC and TAG. Tag must be a minimum of 8,156' to be 50' above the top of the 4-1/2" liner.
2. Operator shall place a Class C cement plug from 6,585'-6,420' to seal the Abo Formation.
3. Operator shall place a Class C cement plug from 4,570'-4,420' to seal the Glorietta Formation.
4. Operator shall place a Class C cement plug from 1,540'-1,000' to seal the Yates Formation.
5. Operator shall perf at 670' and squeeze class C cement to the surface to seal the Salt Formation and the 9-5/8" shoe.
6. Dry hole marker must be below ground.
7. Surface reclamation will need to be completed once the well bore has been plugged. Please contact rflores@blm.gov for additional information.
