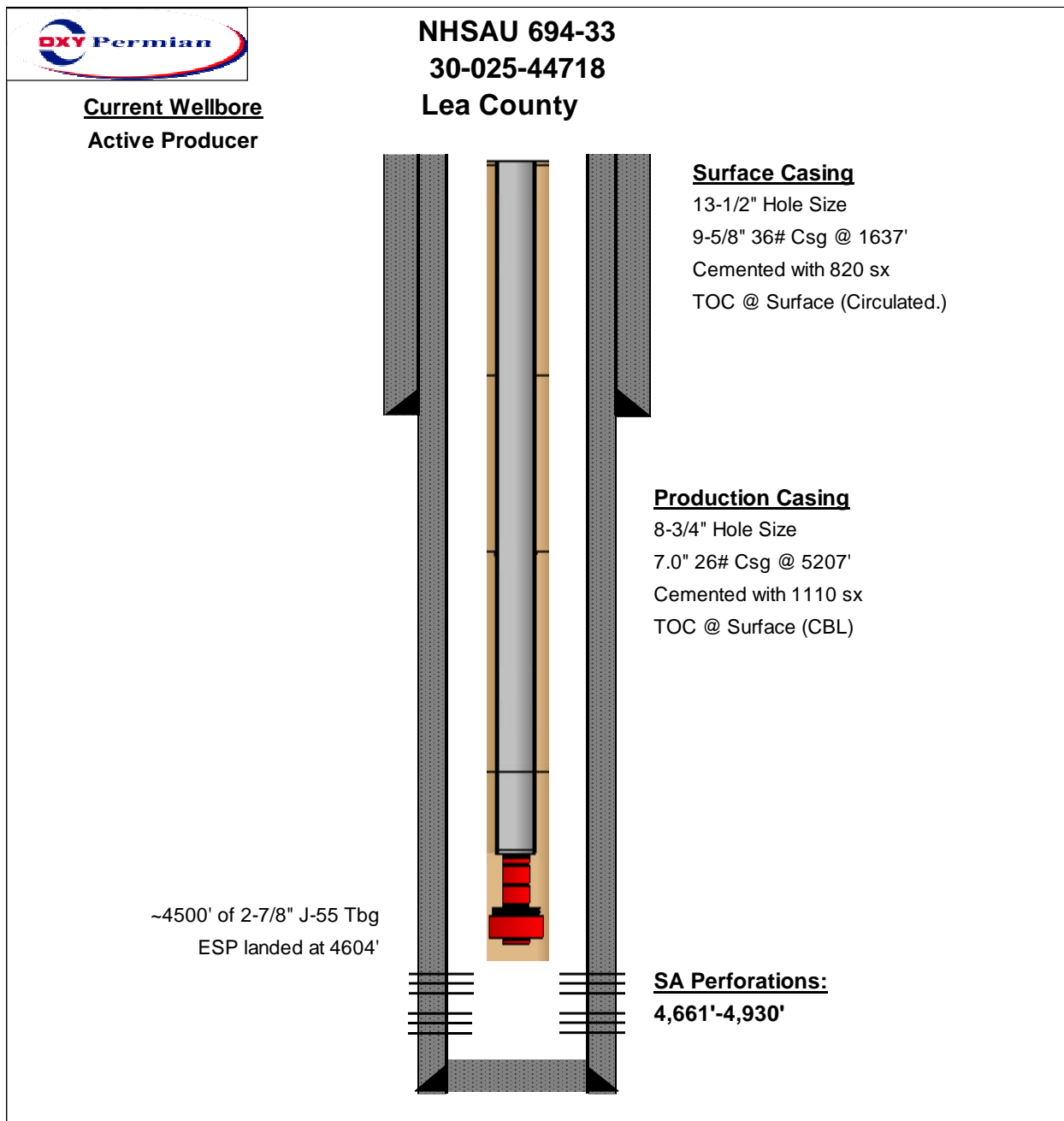

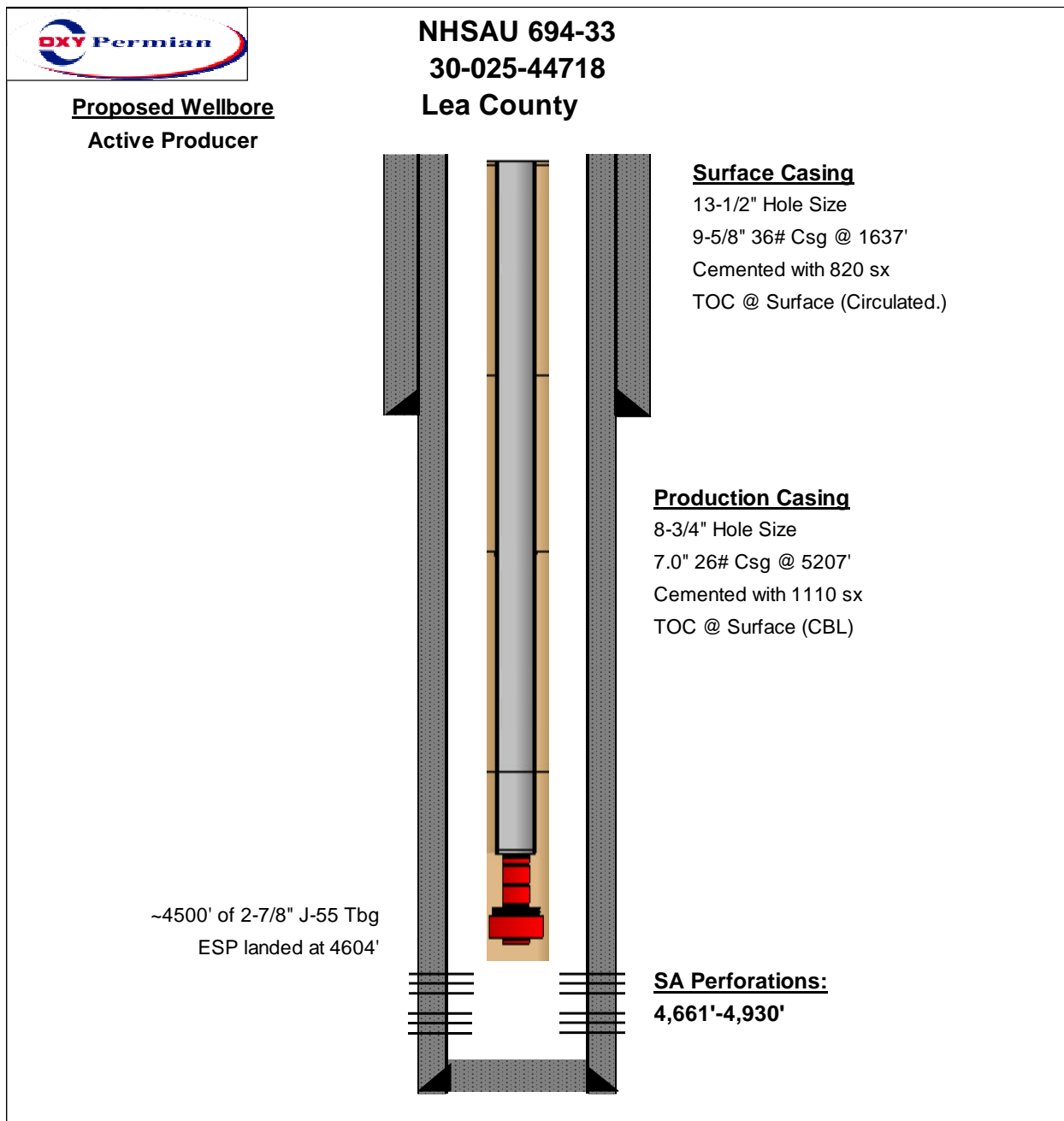
Job Plan

3. POOH w/ prod. Eqpt
4. RU WL x Set CIBP @ 4774' (9' gap in perforations)
5. Dump bail pea gravel/cement to 4730' x RD WL
6. Cement squeeze top of 3E and Zone 2L
7. DO squeeze & CIBP to 5148'
8. Reperforate well excluding top 20' of zone 3E
9. Acidize with PPI tool
10. Run ESP Eqpt
11. RD PU
12. Return well to production
