 - 3844 – 3847
 - 3858 – 3879
 - 3897 – 3906
7. RIH w/ sonic hammer
8. Acidize well with 5,000 gallons of 15% HCL
9. POOH laying down workstring
10. Hydrotest tbg to 80% burst
11. RIH w/ TAC, tbg and rods
 - Pick up 150' of 1-1/2" sinker bars
12. Long stroke pump and ensure good pump action
13. RTP

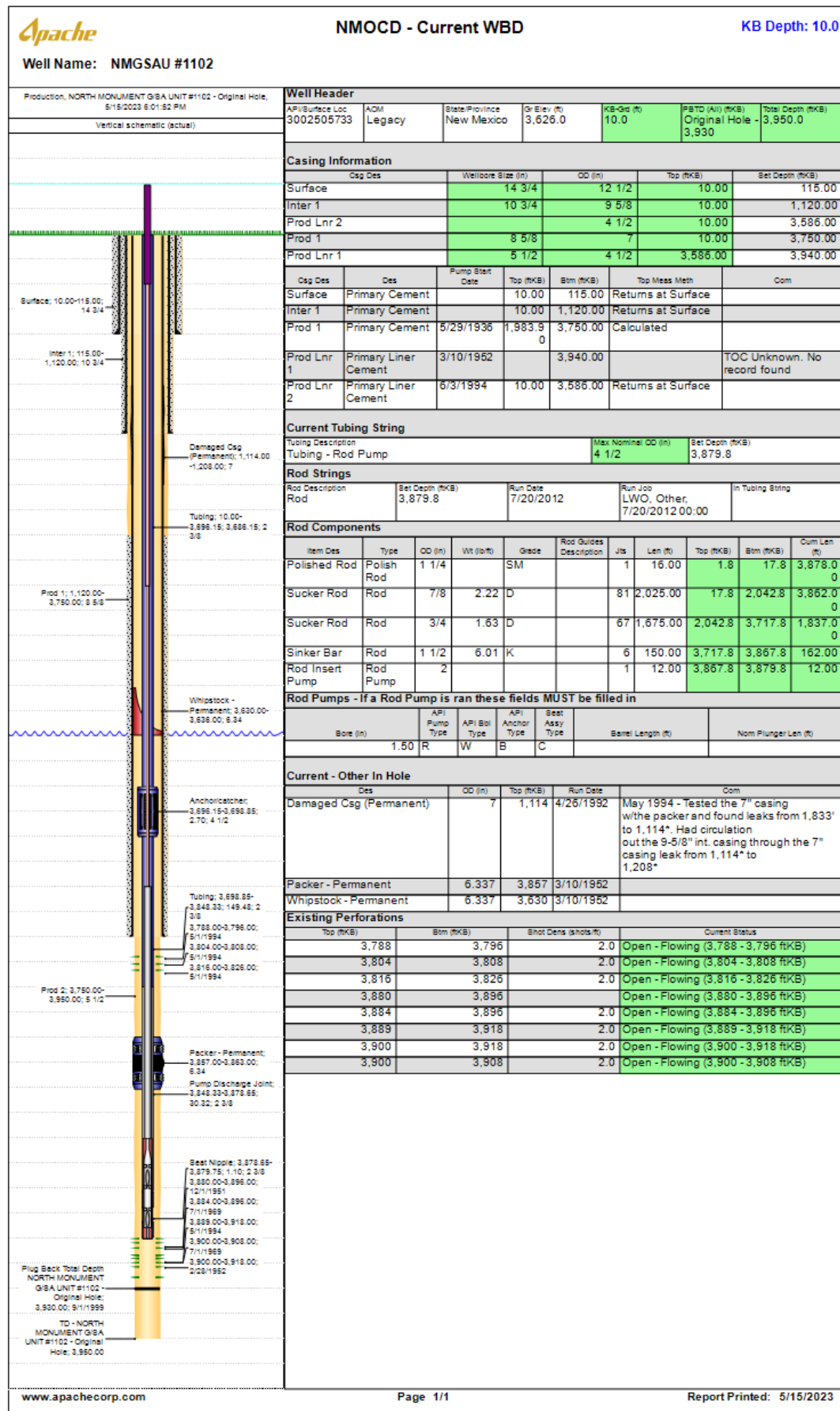
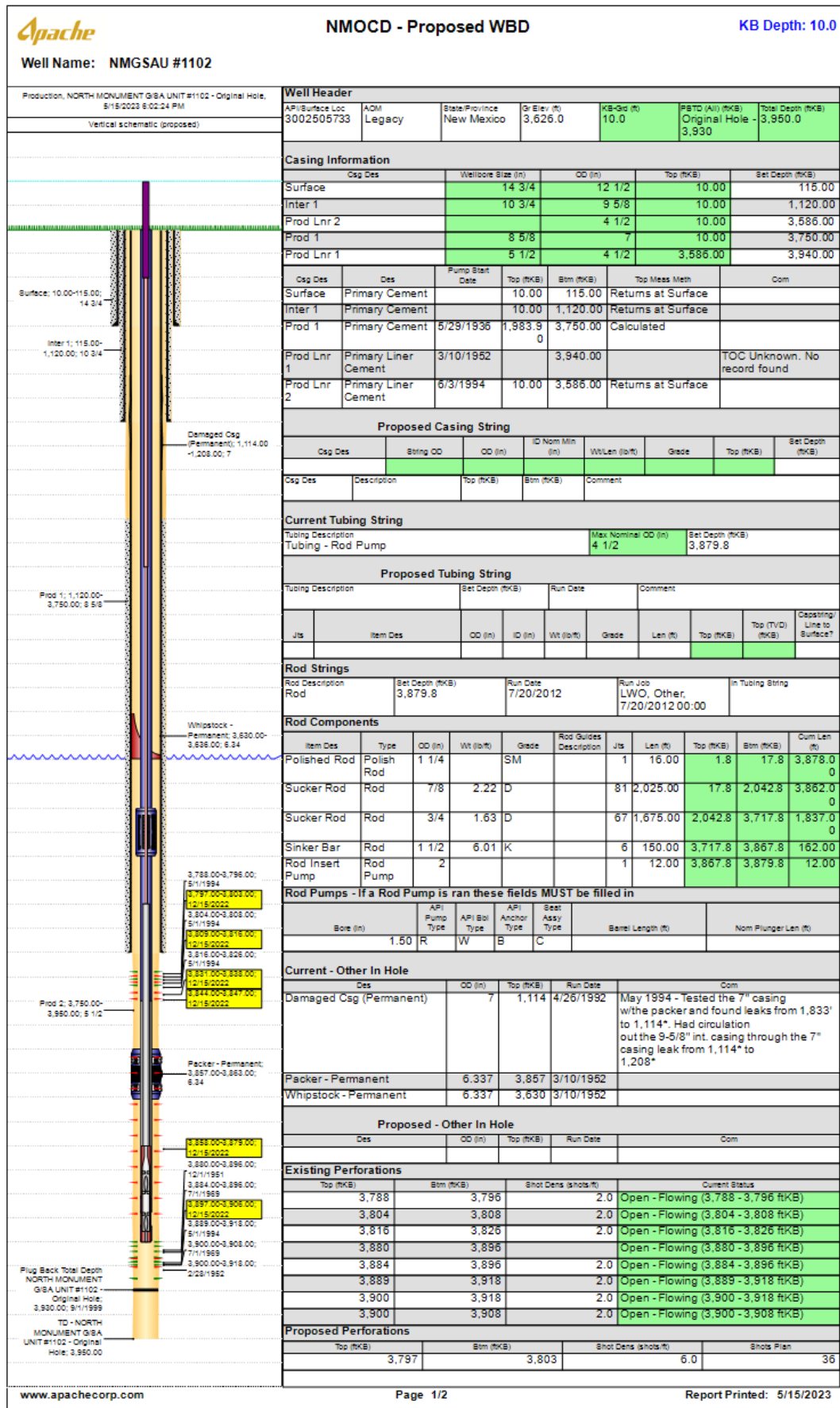
Figure 1 – Current Wellbore Diagram
