2. Lay down injection string
3. RIH w/ bit, workstring and bailer to TD
4. MIRU wireline
5. Add perforations w/ 4 SPF as follow:
 - o 3,800' – 3,864'
 - o 3,865' – 3,975'
6. RIH w/ sonic hammer
7. Acidize well with 6,000 gallons of 15% HCL
8. POOH laying down workstring
9. RIH w/ new 2-7/8" IPC injection string and packer
10. Set packer @ 3,654'
11. Inform NMOCD 24 hrs. prior to performing MIT
12. Return well to injection

Figure 1 – Current Wellbore Diagram

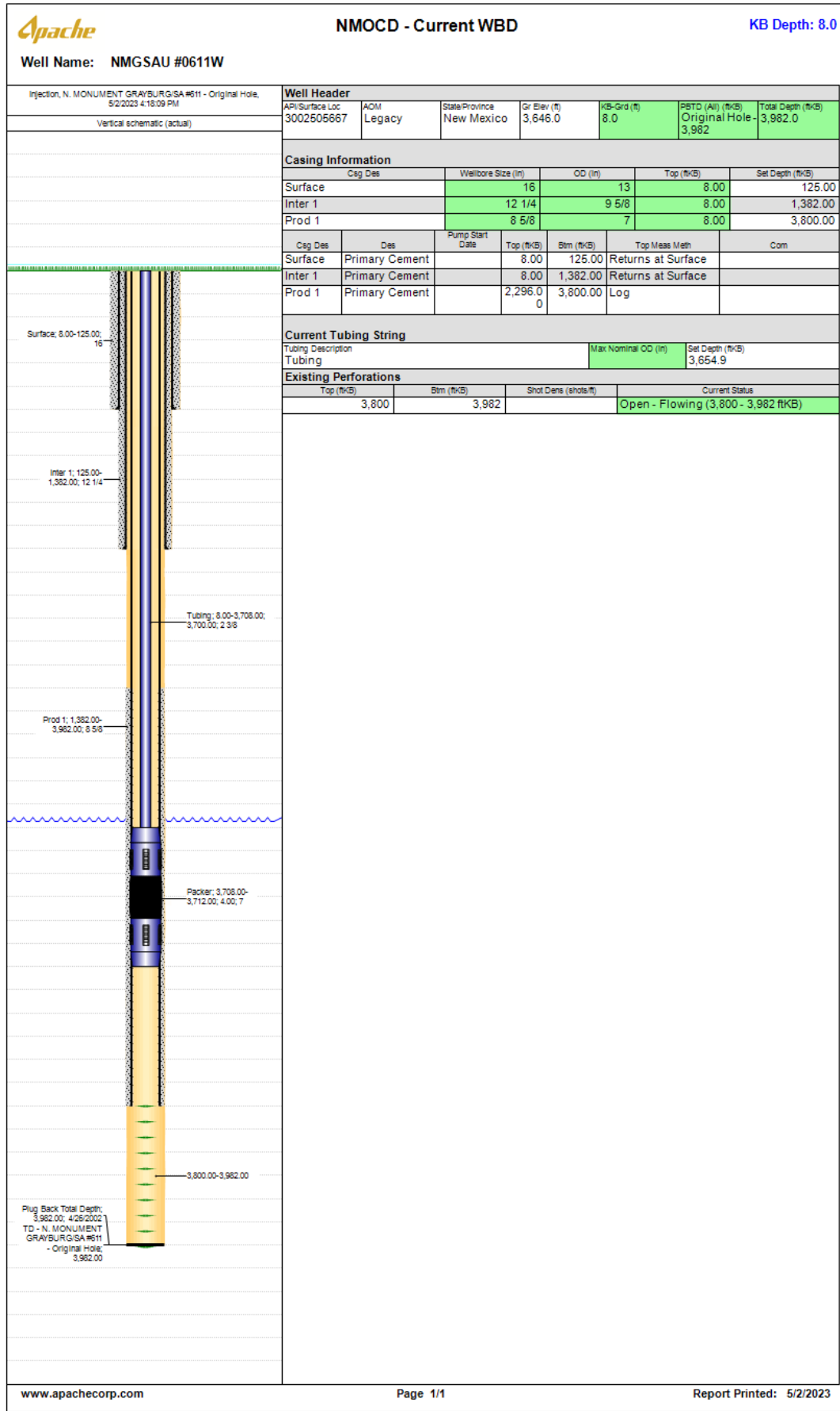
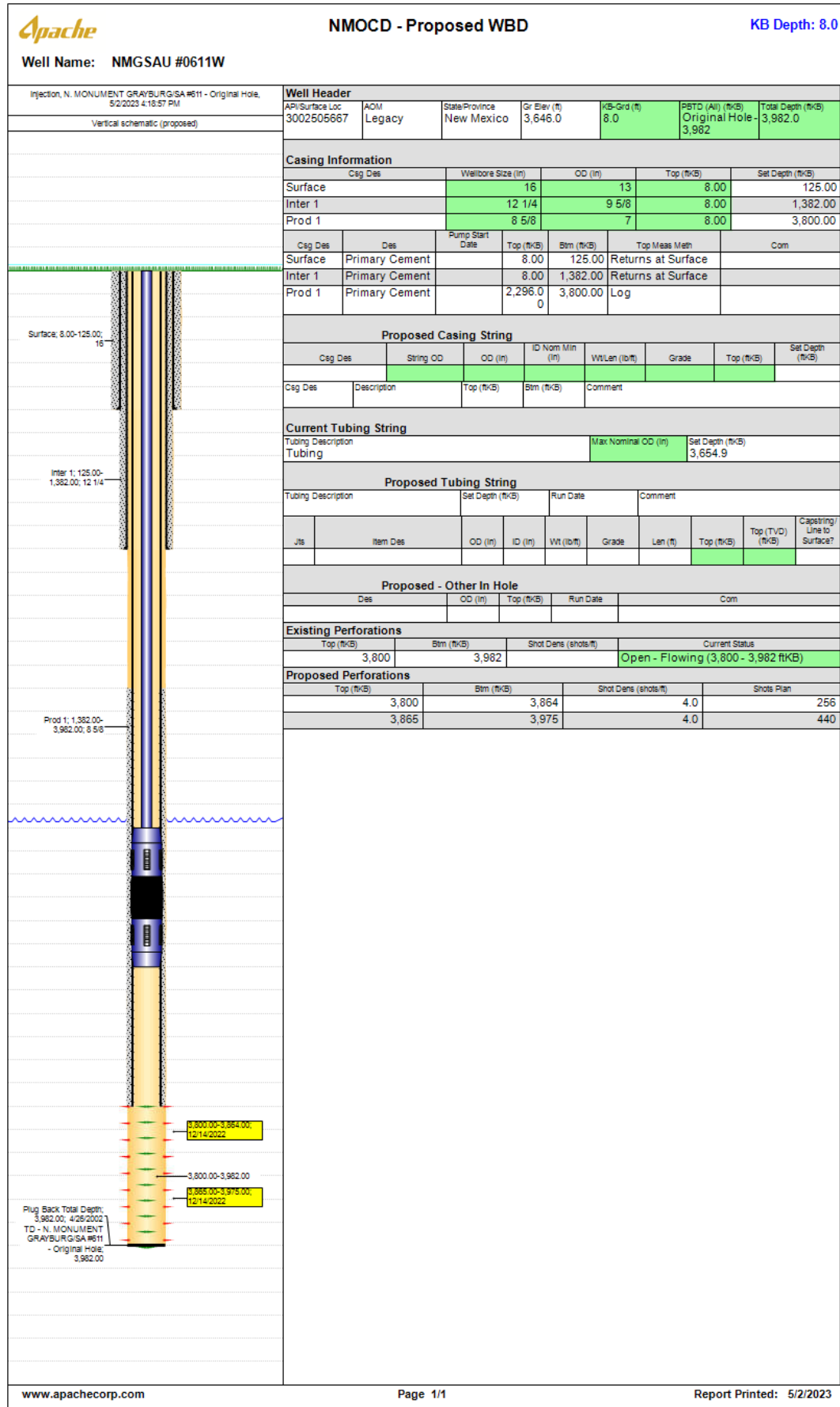


Figure 2 – Proposed Wellbore Diagram
