5. RIH w/ sonic hammer
6. Acidize well with 7,000 gallons of 15% HCL
7. POOH laying down workstring
8. Set packer @ 3,651'
9. Inform NMOCD 24 hrs. prior to performing MIT
10. Return well to injection

Figure 1 – Current Wellbore Diagram

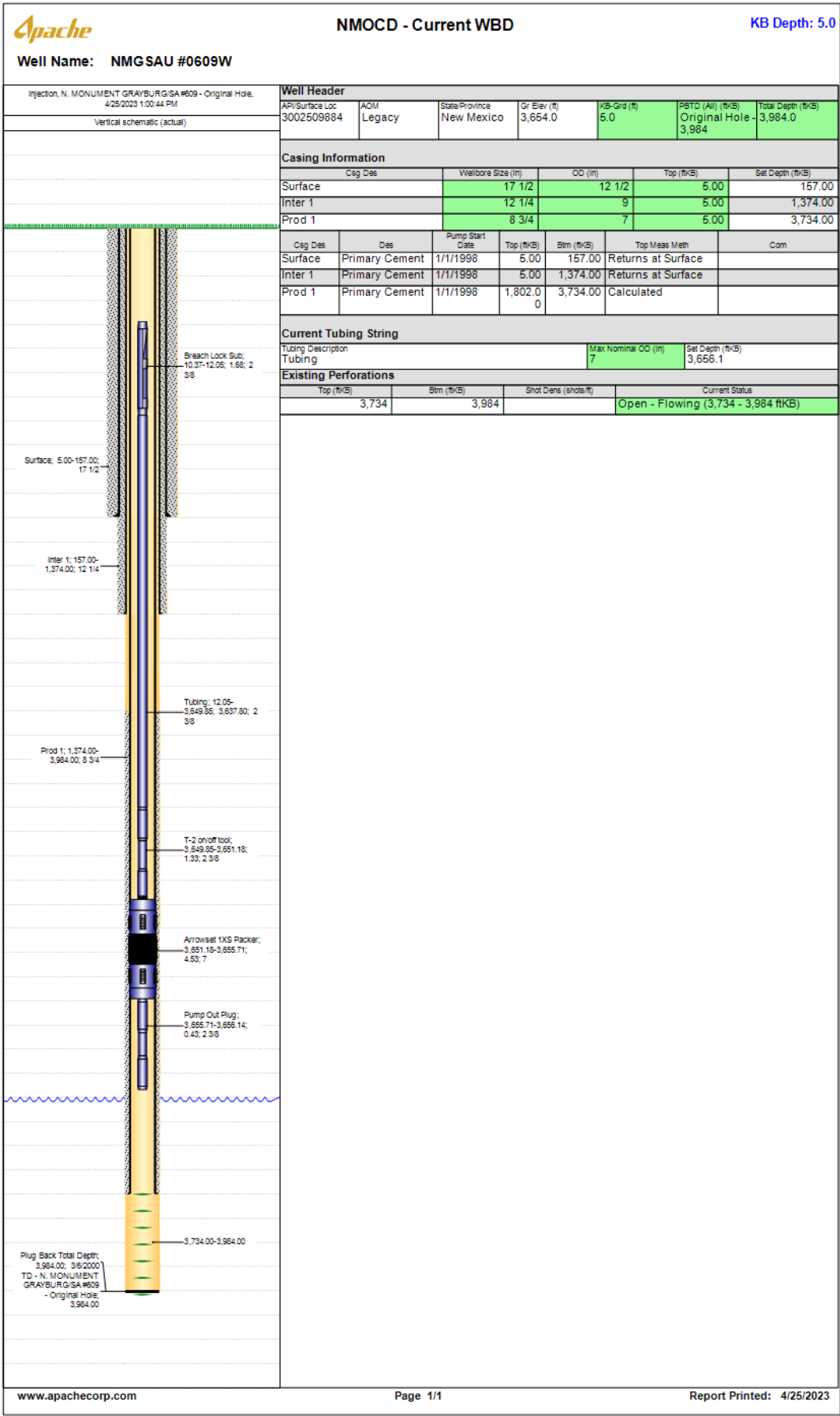
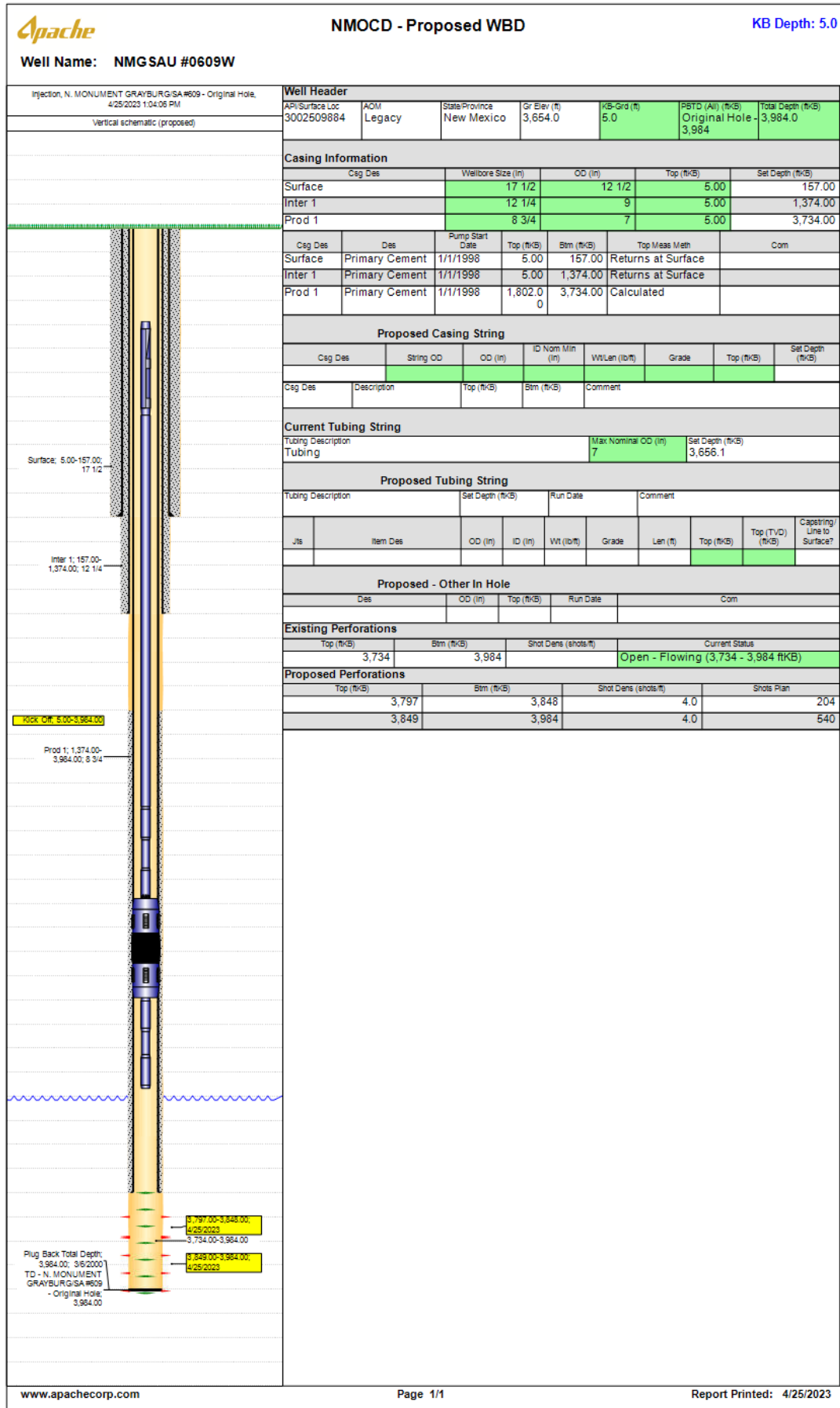


Figure 2 – Proposed Wellbore Diagram
