2. Lay down rod string and take to Monument yard
3. Scan tbg
 - Only keep yellow band equipment
4. Send pump and TAC for repair
5. RIH w/ bit drill out the CIBP @ 3,935'
6. Clean well down to 4,050'
7. Pick up cmt retainer and sqz open perfs
8. Drill out cmt and pressure test sqz to 2,000 psi
9. MIRU wireline and add the following perfs w/ 6 SPF:
 - 3800 – 3825
 - 3834 – 3851
 - 3855 – 3862
 - 3869 – 3879
 - 3884 – 3934
 - 3940 – 3969
10. RIH w/ sonic hammer
11. Acidize well with 4,000 gallons of 15% HCL
12. Lay down workstring
13. Hydrotest tbg to 80% burst
14. RIH w/ TAC, tbg and rods
 - 1,670' of 7/8" Tenaris KD rods
 - 1,800' of 3/4" Tenaris KD rods
 - 500' of 1-1/2" K sinker bars
15. NOTE: replace pump with a 2" pump
16. Long stroke pump and ensure good pump action
17. RTP

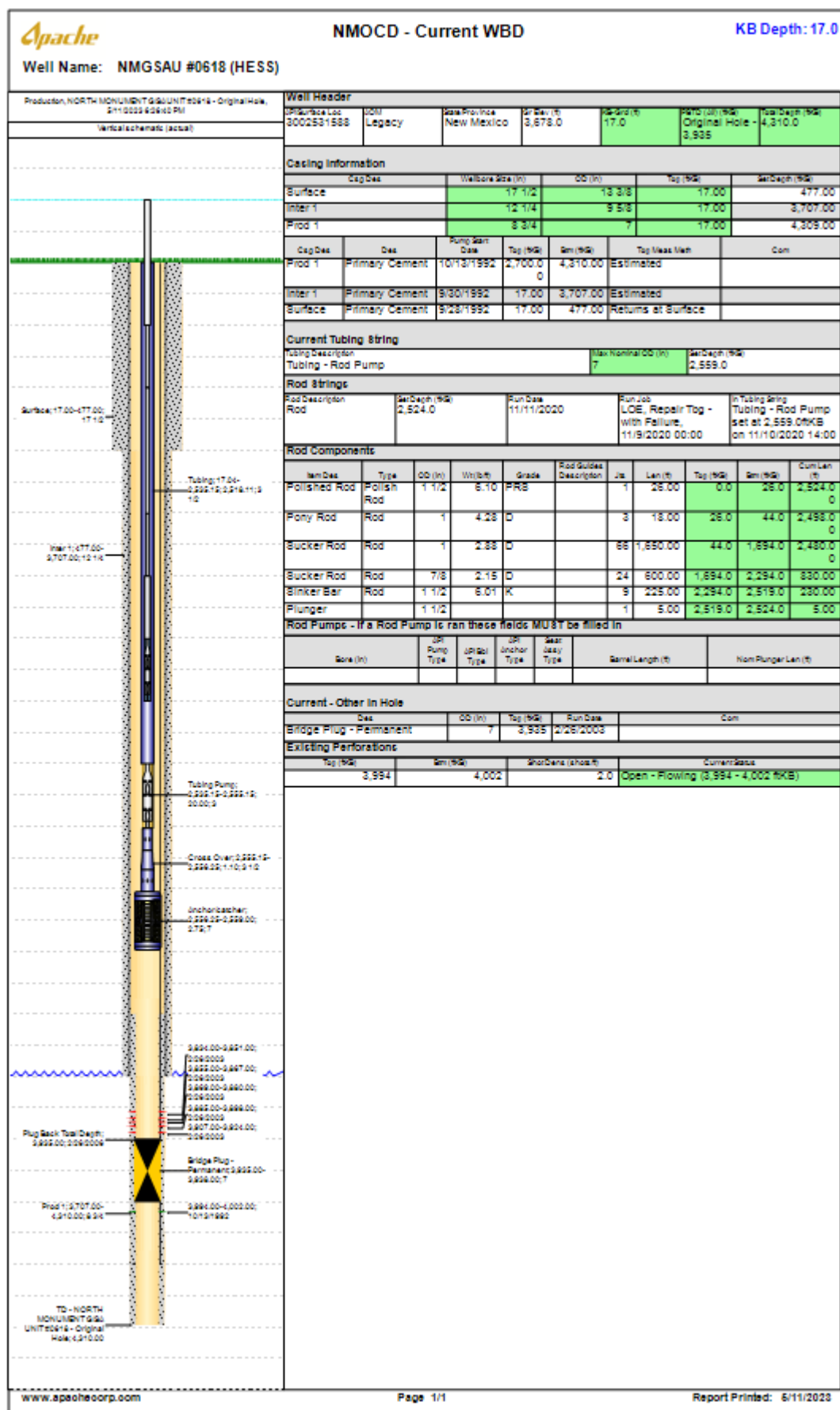
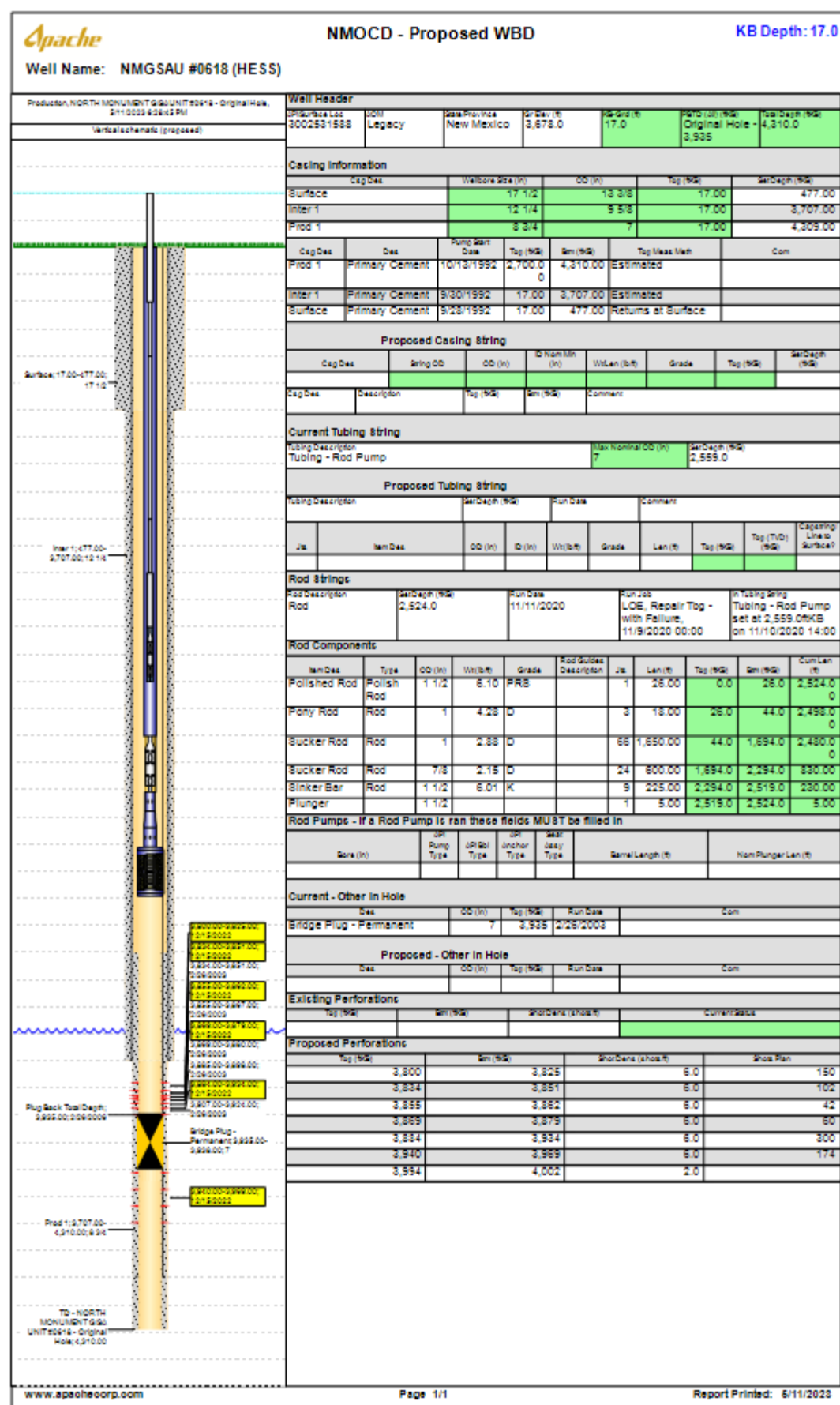
Figure 1 – Current Wellbore Diagram
