Pump 74 bbl spacer, followed by 471 sks of 14.8 ppg tail cmt. Drop plug and displace with 36 bbls freshwater. 2 bbls of cement returned back to surface with top job. EST TOC at 0 ft. Pressure test casing to 1500 PSI for 30 minutes, good test. 3/11/2023: Test BOPS. Drill 9.875 intermediate hole to 8320 ft. 3/17/2023: Run 7.625 inch 29.7 lb P-110 intermediate casing to 8274 ft. Pump 40 bbls gel spacer, followed by 1075 sks of 11.2 ppg lead cmt, 270 sks of 13.2 ppg tail cmt. Drop plug and displace with 377 bbls of fresh water. 10 bbls cement to surface. EST TOC at 0 ft.
