



- 3. Operator shall perf at 384' and squeeze class c cement to surface to seal the 8-5/8" casing shoe.**
- 4. Dry hole marker must be below ground.**
- 5. Surface reclamation will need to be completed once the well bore has been plugged. Please contact rflores@blm.gov for additional information.**
