Rigged up well servicing equipment 6/24/2021. Pressured tubing to 500 psi. Dropped to 200 psi, HIT. Unseated pump (paraffin present). Swabbed tubing while pulling rods. Ran paraffin knife & recovered small amount of paraffin. Changed equipment. Used swab cup (hard dry paraffin present). Ran full swab cup to 5000' and recovered larger amount of paraffin.
 TOH w/tubing (82 stands, approx 5215'). Ran swab in tubing & tagged obstruction @ approx 5515'. Swab went through obstruction. Stopped at 5919' and recovered hard paraffin plug @ 5915'. Pulled tubing & found plug at 5851'. Lay plugged joint down.
 TOH w/tubing & lay down 2 3/8" mechanical SN. Cleaned out SN and removed SV. TOH w/kill string & lay down 3 joints above SN. Picked up new PS w/BP-SN-PC Blast joint-White Band joint.
 TIH while testing tubing to 6000 psi. TIH with replacement pump. Ran unit @ 10% & will increase as needed.
 Rigged down & released rig 7/1/2021. Returned well to production.
