Re-Completion Procedure

SUBJECT WELL: Rosa Unit 643H

RE-STIMULATION:

- 1. MIRU workover rig.
- 2. TOOH with 2-3/8" tubing.
- 3. Rig up air package and TIH w/ bit circulating to cleanout the 4-½" casing and shoe track to 12,410' (Casing TD).
- 4. Rig up casing crew to pull +-6286' 4-1/2" tie back string landed at 6286'.
- 5. Run 3-1/2" liner inside existing 4-1/2" liner. Land 3-1/2" liner at \sim 12,410' with liner hanger in 7" Casing at \sim 6200'.
- 6. Cement 3-1/2" x 4-1/2" annulus using ~225 sx (60 bbl, 13.5 ppg, 1.516 yield) Halliburton SBM CEM ECONOCEM ™ SYS cement blend. Reverse out excess cement.
- 7. PU and RIH with 6-1/8" mill and workstring to tag the top of liner, ensuring the 7" is clean, prior to running 4-1/2" tieback string.
- 8. Run 4-½" tieback string. Sting into 3-½" PBR and set tieback.
- 9. Rig up frac crew and wireline crew to reperforate and stimulate within existing perforation interval (7,550'-12,355') using perf and plug operations and ~10,920 klbs 40/70 and 100 mesh sand with ~278 kbbls water.
- 10. RDMO frac. MIRU 2" coil tubing rig to mill out plugs and cleanout to TD. RD coil.
- 11. MIRU workover rig to install tubing.




