Good test. Drill 17.5" intermediate hole from 1,580' to 2,055'. 10/02/22: Drill and TD 17.5" intermediate casing hole from 2,055' to 2,951'. 10/3/22: Run 13-5/8" intermediate csg. 54.5#, J-55 grade, STC connection, casing to 2,945'. Lead cmt. 1,130 sxs, CLC, Slurry 368.3 bbls.,1.83 cu.ft. Tail cmt. 385 sxs., CLH, Slurry 93.9 bbls., 1.37 cu.ft., circulated 6 sxs. to surface. Pressure test casing to 1,500 psi for 30 minutes, good test. Set test plug and test breaks to 250 psi low/5,000 psi high/10 minutes, each test good.
