
PROPOSED PROCEDURE: MIRU. POOH w/ tbg & pkr. TIH & clean out to 3880'. Circulate hole clean. TOH w/ bit. Re-Perf from 3720' to 3869'. Use pkr & RBP to isolate perf intervals for stimulation. Acidize 3766-3869' w/ 3000 gals 15% NEFE acid, 200# rocksalt w/ 10 bbls brine & flush w/ 48 bbls fw. Acidize 3724-3880' w/ 3000 gals 152% NEFE acid, 300# rocksalt w/ 10 bbls brine & flush w/ 72 bbls fw. POOH & then TIH w/ injection string. Set packer and be ready for injection.
