PROPOSED PROCEDURE: MIRU. Re-Enter P&A'd well. Drill out plugs & CIBP @ ~3700'. Clean out to PBTD @ 3890'. Circulate well clean. Add additional perfs from 3744' to 3760' and acidize w/ 5000 gals 15% NEFE HCL acid, 1500# rocksalt & flush w/ 500 bbls 2% KCL. POOH & then TIH w/ injection string. Set packer and be ready for injection.
