Pump 20 bbls chem wash, 20 bbls gel spacer, followed by 405 sks of 14.8 ppg tail cmt. Drop plug and displace with 63 bbls brine. 35 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
