The 9-5/8" intermediate casing became stuck at a depth of 5,202'. Matador was unable to work the casing free due to hole conditions. The original plan set depth was 5,350'. The casing was cemented in place at 5,202' with good returns, receiving 218bbls of cement back to surface. The subsequent production cement volumes will be adjusted to account for this shallower set depth.
