Rigged up Hot Oiler and pumped 70 bbls paraffin chemical. PU pump and RIH with rods. Spaced out well, hung HH and load tested. Held. Verified pump action. Released rig and cleaned up location. Placed well back on production to common facility. Prod Volumes prior to repair: Oil 0 bbls, Gas 0 mcf, Water 0 bbls. Prod Volumes after repair: Oil 3 bbls, Gas 1 mcf, Water 12 bbls.
