Ran PU 1" pipe & tage @ 134'. Ran 1" pipe in 8 stages with 600 sks class C w/6% CaCl2. Mixed @ 12.6#/g w/2.31 yd. Circ 75 sks of cmt to the cellar. Tested BOPE to 5000# & Annular to 3500#.
