Unhung well. Run in with on/off tool and free rods. POOH with rods. RIH to drift, tag at 3816'. Rig up hydrostatic tbg scanners. POOH with tbg and test. Hole in TAC mandrel. Tag again at 3816'. Rig up hot oil. Make hole to 3825' on water, work sonic hammer across perfs 3825' to 3745'. Pump acid, flush with water. RD hot oil, ND stripper head. 10 swab runs. Recover water and no solids. RIH and tag at 3816', no fill. RIH with tbg. Dump 5 gal CI on tbg. RIH with rods. Return well to production.
