Well status as of 9-21-23:

The well is still bubbling from 9-5/8" x 13-3/8" annulus at surface. No well head is present. We plan to install a well head over the 13-3/8" surface casing to isolate the intermediate to surface casing annulus that the gas is escaping from. We will install a valve and gauge to monitor pressure, bleed, and capture gas. A gas sample will be captured and analyzed, and the well will be monitored monthly until 1/16/24 to ensure flow is not accelerating. At this point (and depending on the gas analysis) the well will be deemed appropriately plugged or we will have a plan to re-enter and remediate P&A.

I received approval from Keith Immatty at BLM to leave this well to dissipate what appears to be entrained air over the next six months. No action is currently required to bradenhead squeeze or drill out cement. We are also approved to postpone marker installation on the wellhead.

During the next six months, Keith requested we perform a visual check on the annulus on a weekly basis. I will try to coordinate that with field personnel for whom it's most convenient.
