MU and TIH with 4 ½" cement retainer, set retainer at 1064'. Load and roll hole. PT casing, did not test.

P&A Plug 1: Fruitland Coal perforations, Fruitland, and Kirtland formation tops: Mix and pump a plug of 56 sx, (12 sx through retainer and into Fruitland perforations, sting out and place 44 sx above retainer). TOO H. WOC.



11-28-2023: Plug 2: Kirtland, Ojo Alamo, surface casing shoe to surface. Mix and pump balanced plug of 38 sx from 480'. TOO. Tagged plug 2 at 49' in 4 1/2" casing.

11-27-2023: Plug 1: Fruitland perms, Fruitland, Kirtland: Set CR at 1064'. Load and roll hole. PT casing, did not test. Mix and pump plug of 56 sx, (12 sx through CR into Fruitland perms and 44 sx above CR). WOC. 11-28-2023: Tagged Plug 1 at 480'.

11-27-2023: Portion of 2 3/8" mud anchor broke off due to corrosion. Obtained approval to leave in the hole.
