**10/30/23:** MOL. Held JSA. Prep road to location and prep location. Spot equipment. Check well pressures; no pressure on well. RU rig and plugging equipment. ND wellhead and NU and test BOP. PU on tubing, stuck. LD prod tbg, 32 jnts, tbg parted, called for fisherman. RU A Plus WL, RIH w/ GRJB to verify depth, tagged @ 1050', RD WL. TIH w/ OS to latch onto fish, chased fish down to 1830', would not latch, TOO H and stand back tbg. Secure well and SDFD.

**10/31/23:** Held JSA. Called Deon David w/ NMOC D, approved to continue to fish tbg. TIH w/ OS, latched onto tbg, moved up hole then OS released. TOO H, no fish. Redress OS and try to latch on again, would not latch, TOO H no fish. RU A Plus WL, RIH w/ GRJB to 1798'. Called into Deon David w/ NMOC D, approved to set CIBP @ tagged depth. RIH w/ 4-1/2" CIBP, set @ 1798'. RD WL. Load well w/ 30 bbls. Secure well and SDFD.

**11/1/23:** Held JSA. RU JSI WL, RIH and run CBL from 1798' to 1500', log cut out, lost fluid. Try to load well, would not load, RD WL. TIH RU pump to tbg.

**Plug #1.** Spot 25 sxs Class G cmt from 1798' to 1898'. TOO H w/ tbg, WOC for 3 hrs. Try to load well, pumped 60 bbls, did not load. RU JSI WL, try to log well from 1700', no fluid at all, RD WL. TIH w/ tbg, RU pump.

**Plug #1A.** Spot 25 sxs Class G cmt from 1700' to 1600'. TOO H and WOC overnight. Secure well and SDFD.

**11/2/23:** Held JSA. RU A Plus WL, RIH w/ GRJB tag Plug #1A @ 1600', RD WL. Load well. RU JSI WL, RIH and run CBL from 1600' to surface, RD WL. RU A Plus WL, RIH and perf @ 1344', RD WL. TIH w/ 4-1/2" packer, set and RU pump to tbg. Try to establish ROI, pressured up to 500#, no rate. TOO H and remove packer. Called into Deon David w/ NMOC D, directed to spot plug 50' below perforation plug original plug from 1394' to 1094'. TIH w/ tbg, RU pump and circulate well.

**Plug #2.** Spot 30 sxs Class G cmt from 1394' to 1094'. TOO H and WOC overnight. Secure well and SDFD.

**11/3/23:** Held JSA. TIH and tag Plug #2 @ 1020'. TOO H. RU A Plus WL, RIH and perf @ 403', RD WL. TIH w/ 4-1/2" packer, set and RU pump to tbg to est. circulation.

**Plug #3.** Spot 145 sxs G cmt from 403' to surface. RD workfloor. ND BOP. RD plugging equipment and rig. MOL. SDFN.

**11/7/23:** Travel to location. Dig out, cut off and remove wellhead. TOC @ surface in annulus. Weld on and install P&A Marker @ 33\*04'03.9"N-103\*58'57.5"W. MOL.


