The request to extend the temporary abandonment (TA) is approved with the following conditions:

1. No well shall be TA without prior approval from the authorized officer or representative.
2. This approval is granted for a 12-month period until November 1, 2024. Before this approval expires one of the following shall be submitted:
 - a. A sundry notice (Notice of Intent – Temporary Abandonment) to keep the well in TA status with engineering and/or economic justification for up another 12-month period. Provide details on the future beneficial use for the well with proposed dates.
 - b. A sundry notice (Notification – Resume Production) with resumption of production reported.
 - c. A sundry notice (Notice of Intent – Plug and Abandonment) to plug and abandon (P&A) the well. While not necessary to P&A before November 1, 2024, a sundry notice must be submitted prior to that date. The P&A will then have to occur within one year of the approval of the NOI.
3. This agency reserves the right to modify or rescind approval. A plug or produce order may still be issued at the discretion of the authorized officer.

4. The lease is currently held by production from other wells. Should production from the lease cease, the BLM may require this well be returned to production or P&A, regardless of the amount of time the TA status is still approved for.
