Mr. Lowe:

Included with this letter are the following documents demonstrating that the above referenced well will be drilled at a standard oil well location despite the customary non-standard position within the proposed spacing unit:

- C-102 Plat dated November 15, 2023, showing the proposed location of the Boll Weevil 27-34 Fed Com 5H;
- "Area of Common Ownership Plat" separately showing the spacing units for the Boll Weevil 27-34 Fed Com 5H; and
- Certification of Ownership demonstrating the outlined area on the plat is comprised of uniform ownership throughout the entire spacing unit.

19.15.16.15.C(7) NMAC provides that in an area of common ownership (here, two federal leases) the setback requirements only apply to the outer boundary of the area of uniform ownership, not the spacing unit within the area of uniform ownership. Since the area to the West towards which this well encroaches is within the documented "area of common ownership," this well is at a standard location and approval of a non-standard location (NSL) for the well is not necessary.

Please place this Notification and Verification of a Standard Well Location in the well files for Boll Weevil 27-34 Fed Com 5H, API # 30-025-47952.

Devon Energy Production Company, L.P. respectfully submits the following: Attached hereto is a Letter/statement from Devon's Landman confirming that the Section 27 and Section 34, Township 26 South, Range 34 East, Lea County, New Mexico is an area of uniform ownership, meaning the entirety of 27 and 34, Township 26 South, Range 34 East, Lea County, New Mexico has uniform interests as to the mineral estate in the Bone Spring formation. Accordingly, Devon understands the setback requirements do not apply to the eastern/western boundary lines of the horizontal spacing unit of the Wells pursuant to NMAC 19.15.16.15(C)(7) and therefore approval of a non-standard location is not necessary.

Devon respectfully requests this Form C-103 be placed in the well file for the well as confirmation of its standard location




