Mr. Lowe:

Included with this letter are the following documents demonstrating that the above referenced well will be drilled at a standard oil well location despite the customary non-standard position within the proposed spacing unit:

- C-102 Plat dated November 15, 2023, showing the proposed location of the Boll Weevil 27-34 Fed Com 10H;
- "Area of Common Ownership Plat" separately showing the spacing units for the Boll Weevil 27-34 Fed Com 10H; and
- Certification of Ownership demonstrating the outlined area on the plat is comprised of uniform ownership throughout the entire spacing unit.

19.15.16.15.C(7) NMAC provides that in an area of common ownership (here, two federal leases) the setback requirements only apply to the outer boundary of the area of uniform ownership, not the spacing unit within the area of uniform ownership. Since the area to the East towards which this well encroaches is within the documented "area of common ownership," this well is at a standard location and approval of a non-standard location (NSL) for the well is not necessary.

Please place this Notification and Verification of a Standard Well Location in the well files for Boll Weevil 27-34 Fed Com 10H, API # 30-025-47957.

Accordingly, Devon understands the setback requirements do not apply to the eastern/western boundary lines of the horizontal spacing unit of the Wells pursuant to NMAC 19.15.16.15(C)(7) and therefore approval of a non-standard location is not necessary.






