ND WH, NU BOP. Unset TAC. RIH tag bottom. POOH with tubing. Pumped 30 bbls KCL. Pulled pump out of tubing. Washed desander out. RIH with 20 stds kill string. POOH. CIH with tubing. Loaded well with KCL water. Started clean out. RD swivel and reverse unit. Continued POOH. TIH with bull plug. TIH with rods. Pressure tested to 500 psi, held good. Rigged down well servicing equipment and cleaned location. Returned well to production on 1/26/2024.
