Procedure Description: Procedure to Repair Failed MIT on Injection Well 4/08/24 1. Move in rig up workover rig. Bleed off well head pressure. ND wellhead and NU BOP. 2. Unhook injection line and meter run. 3. ND wellhead and NU BOP. 4. Unset packer. Pull out of hole with tubing. Inspect tubing as pulling out of hole. 5. Send packer to shop for redress or replace with new packer based on condition. 6. Replace tubing as needed from visual inspection. 7. Pick up reconditioned or new packer and run in hole on the tubing while testing the tubing below the slips to 4500 psi (test tools to be coated). Replace tubing as needed. 8. Once on depth above perforations, circulate in packer fluid (corrosion inhibitor and biocide) mixed in fresh water. 9. Set packer. ND BOP and NU wellhead. Install meter run. 10. Notify NMOCD field representative to witness test. Perform mechanical integrity test. Return to water injection.

Conditions of Approval for Workover/Deepening of a Well

- 1. <u>Notification:</u> Contact the appropriate BLM office at least 24 hours prior to the commencing of any operations. For wells in Eddy County, call 575-361-2822. For wells in Lea County, call 575-689-5981
- 2. <u>Blowout Preventers</u>: A blowout preventer (BOP), as appropriate, shall be installed before commencing any operation. The BOP must be installed and maintained as per API and manufacturer recommendations. The minimum BOP requirement is a 2M system for a well not deeper than 9,100 feet, a 3M system for a well not deeper than 13,600 feet, or a 5M system for a well not deeper than 22,700 feet (all depths are for measured well depth).
- 3. Cement: Notify BLM if cement fails to circulate.
- 4. <u>Subsequent Reporting:</u> Within 30 days after work is completed, file a Subsequent Report (Form 3160-5) to BLM. The report should give in detail the manner in which the work was carried out. <u>Show date work was completed</u>. If producing a new zone, submit a Completion Report (Form 3160-4) with the Subsequent Report.
- 5. <u>Trash</u>: All trash, junk and other waste material shall be contained in trash cages or bins to prevent scattering and will be removed and deposited in an approved sanitary landfill. Burial on site is not permitted.
- 6. If well location is within the Timing Limitation Stipulation Area for Lesser Prairie-Chicken: From March 1st through June 15th annually, activities will be allowed except between the hours from 3:00 am and 9:00 am. Normal vehicle use on existing roads will not be restricted.


