RELEASE OF SURFACE USE LIABILITY

This Release of Surface Use Liability ("Agreement") is entered into on this 27 day of MARCH, 2024 (the "Effective Date"), by and between, Sergio A. Tavarez, whose mailing address is PO BOX 414, Jal NM 88252 ("Surface Owner"), and FAE II, LLC whose mailing address is 11757 Katy Freeway #725, Houston, Texas 77079("Lessee").

WHEREAS, Surface Owner is the owner of the surface estate, and Lessee is the owner and/or the operator of an oil and gas lease or leases covering the following described land in Lea County, State of New Mexico (the "Land"):

The Southwest quarter (SW4) of the Northwest quarter (NW4) of Section 20, Township Twenty-five (25) South, Range Thirty-seven (37) East, New Mexico Principal Meridian

WHEREAS, Surface Owner and Lessee desire to enter into an agreement evidencing the release of Lessee from all liability resulting from or related to Lessee's use of the Land, and further desire to stipulate and agree as to the condition of the surface estate of the Land.

NOW THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Surface Owner does hereby release Lessee, its successors and assigns, from all liability resulting from or related to Lessee's use and activities on the Land prior to the Effective Date.

Furthermore, Surface Owner and Lessee agree that: (1) each party has inspected the Land; (2) each party has concluded that no measurable or compensable damages to the Land have occurred as a result, either directly or indirectly, of Lessee's use and activities on the Land; and (3) Lessee's use and activities on the land was at all times in compliance with all federal, state and local laws and regulations in connection with Lessee's surface operations on the Land.

Finally, Surface Owner requests. and Lessee agrees, to leave all remaining caliche and other road or well pad building materials on the Land; and Surface Owner agrees that Lessee shall have no liability or responsibility after the Effective Date with respect to said caliche and other road or well pad building materials on the Land, and Lessee shall have no obligation after the Effective Date to restore the Land to the same condition as it was before the commencement of Lessee's operations and activities.

Surface Owner and Lessee agree that this Agreement contains the final agreement of the parties as to the matters addressed, and supersedes any and all prior oral or written negotiations, understandings and agreements. This Agreement may not be modified unless the modification is in writing and is signed by the Surface Owner and the Lessee. This Agreement is binding upon the successors and assigns of the Surface Owner and Lessee.

This Agreement is executed as of the date of the acknowledgments below, but shall be deemed effective for all purposes as of the Effective Date.
