TAIL: Type III/Poz, 46 bbls (151sx), 13.5 ppg, 1.71 yield, 8.88 gps (4284 5991). Bump plug at 2800, hold for 5min. Floats held. Circulate. No cement back to surface.

4/17/24: CBL ran. TOC called at 330. Per OCD, Monica Kuehling no remediation required.
